

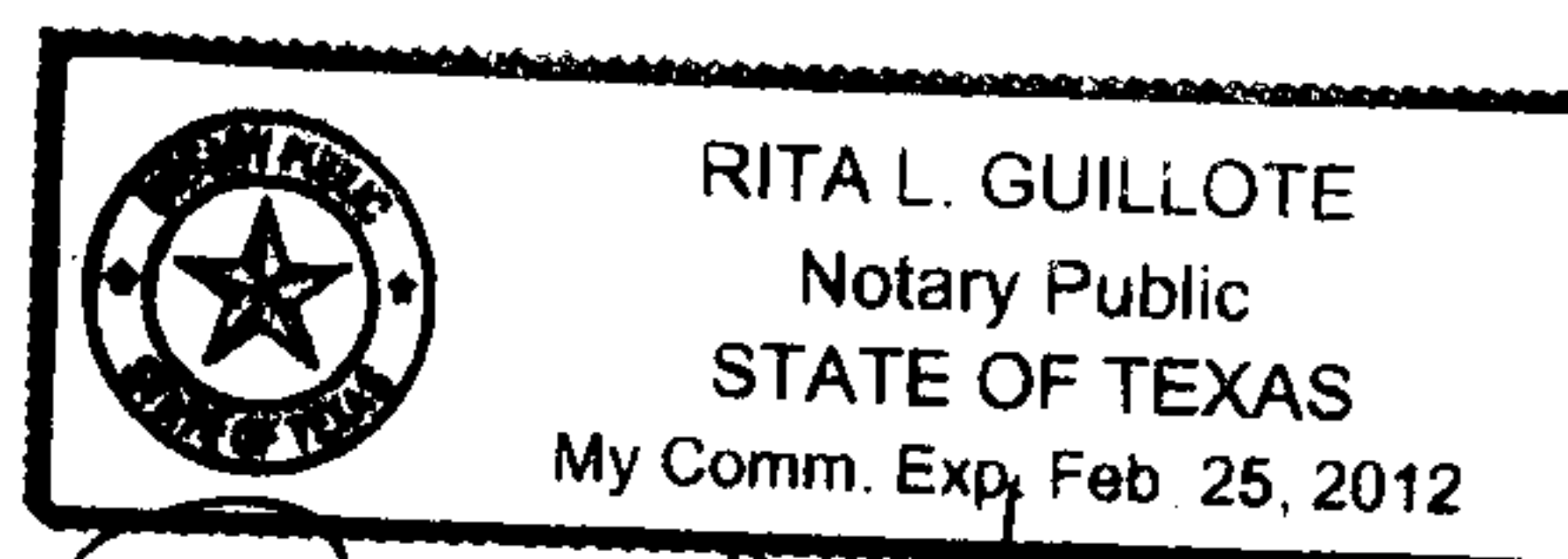


This instrument is to be construed and interpreted as a Specific Power of Attorney.

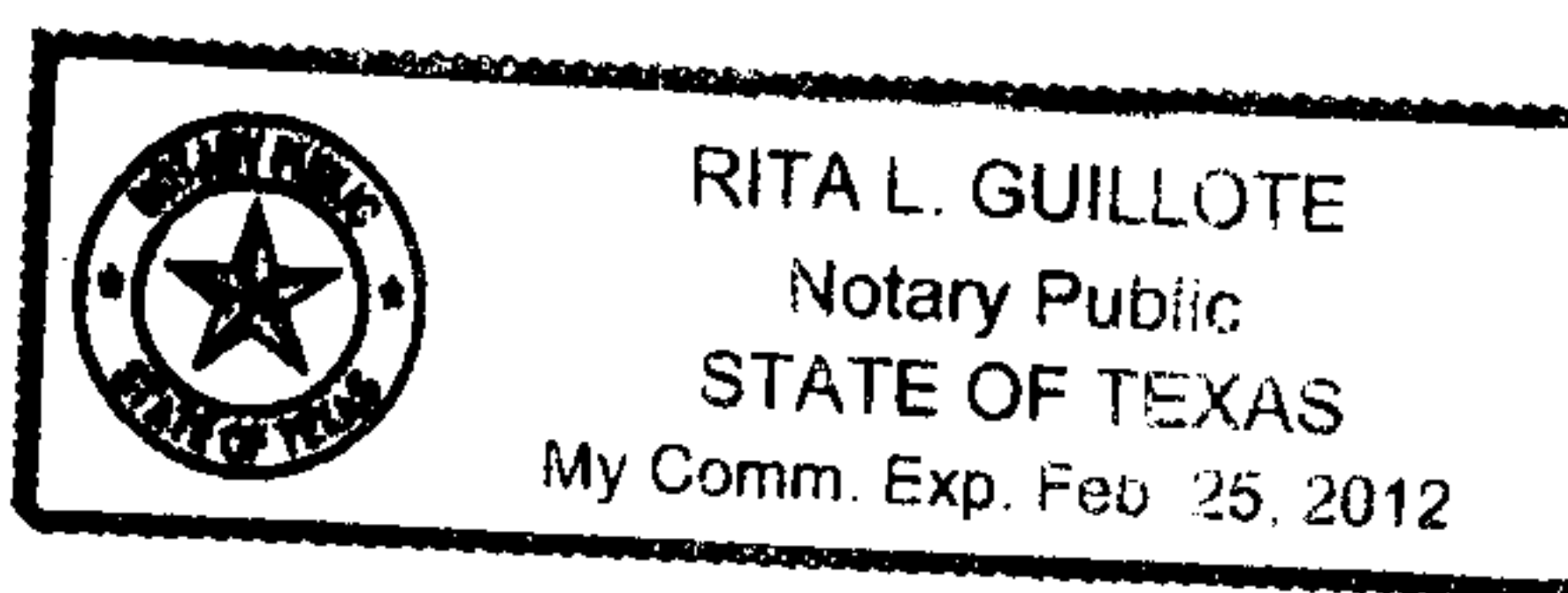
