FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 3rd day of March, 2005, Maureen Stevenson and Scott Stevenson, a married couple, executed that certain mortgage on real property hereinafter described to Wells Fargo Bank, N.A., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20050407000162750, said mortgage having subsequently been transferred and assigned to US Bank National Association, as Trustee for the holders of Citigroup Mortgage Loan Trust Inc., Asset-Backed Pass-Through Certificates, Series 2005-WF2, by instrument recorded in Instrument Number 20110505000135760, in the aforesaid Probate Office ("Transferee"); and

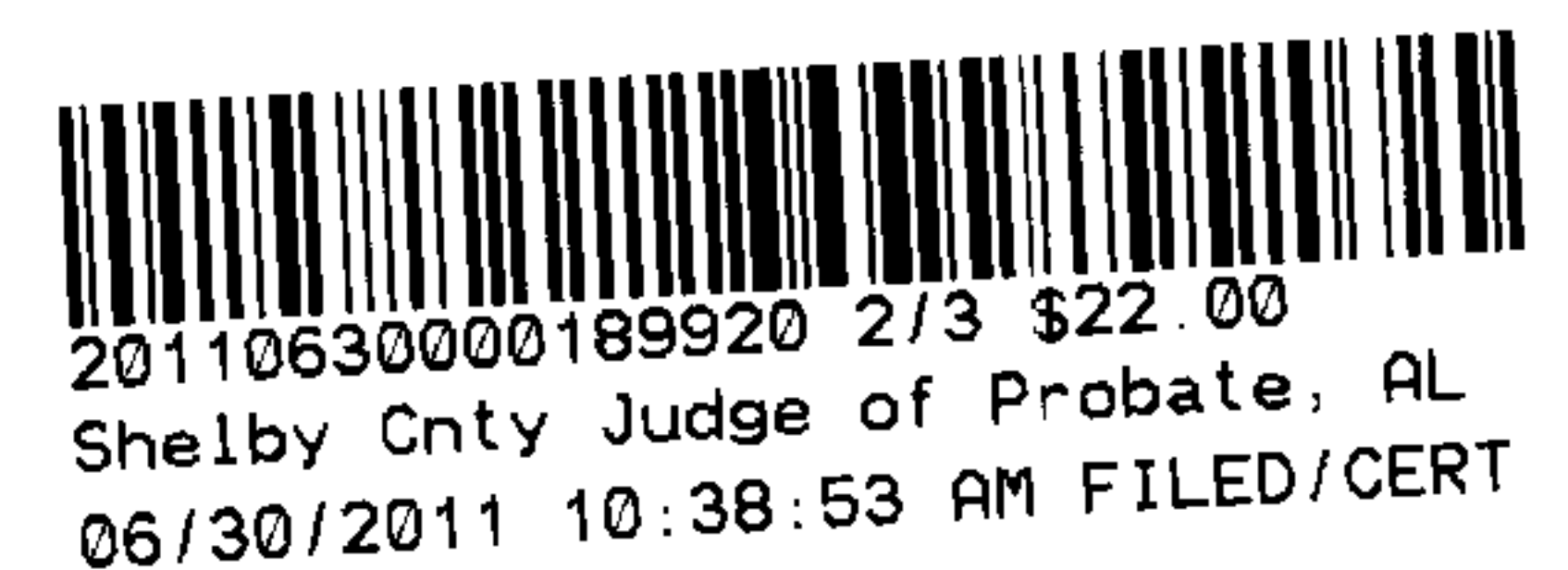




