FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of May, 2007, Jim M. Sarris, a single man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. as nominee for Equifirst Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070607000265490, said mortgage having subsequently been transferred and assigned to Selene RMOF REO Acquisition LLC, by instrument recorded in Instrument Number 20100908000290560, in the aforesaid Probate Office ("Transferee"); and

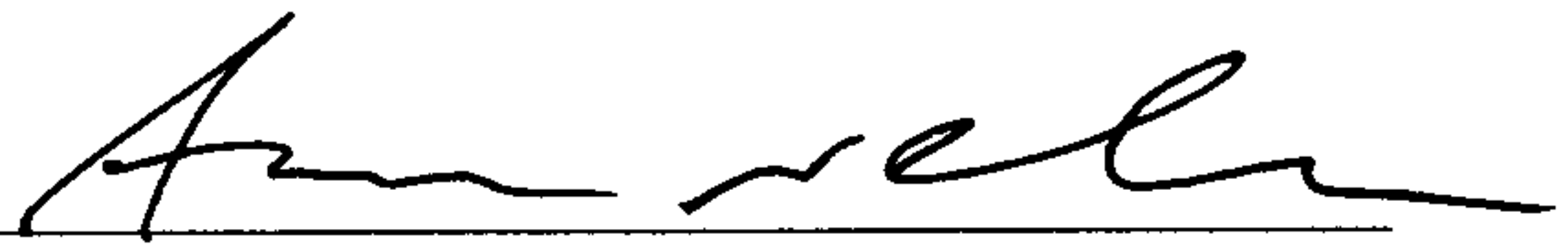

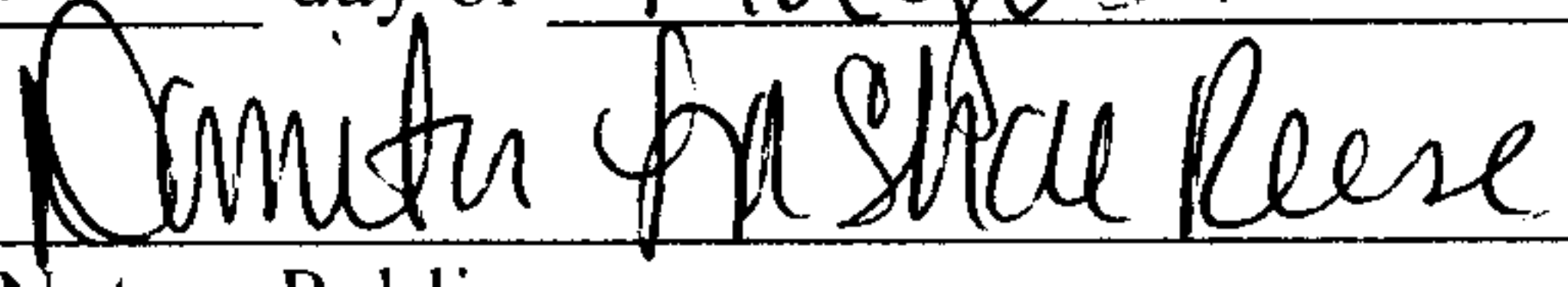
