ARTICLES OF ORGANIZATION

OF

SURE DIRECTION, LLC

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, desiring to form a Limited Liability Company under the laws of the State of Alabama, do hereby adopt the following Articles of Organization effective as of the 25th day of July, 2011:

ARTICLE I

NAME

The name of the Limited Liability Company shall be SURE DIRECTION, LLC (the Company").

ARTICLE II

PERIOD OF DURATION

The term for which the Company is to exist as a Limited Liability Company shall commence on the date these Articles of Organization are filed in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue until the Company shall be dissolved: (a) upon the written consent of all of the Members; (b) as provided in the Operating Agreement; (c) as may be required by the Alabama Limited Liability Company Act, as the same may be amended from time to time; or (d) by any other act or event specified by law as one effecting dissolution.

The Company is formed to transact any and all lawful business for which a Limited Liability Company made be organized under the Alabama Limited Liability Company Act, including, but not limited to
