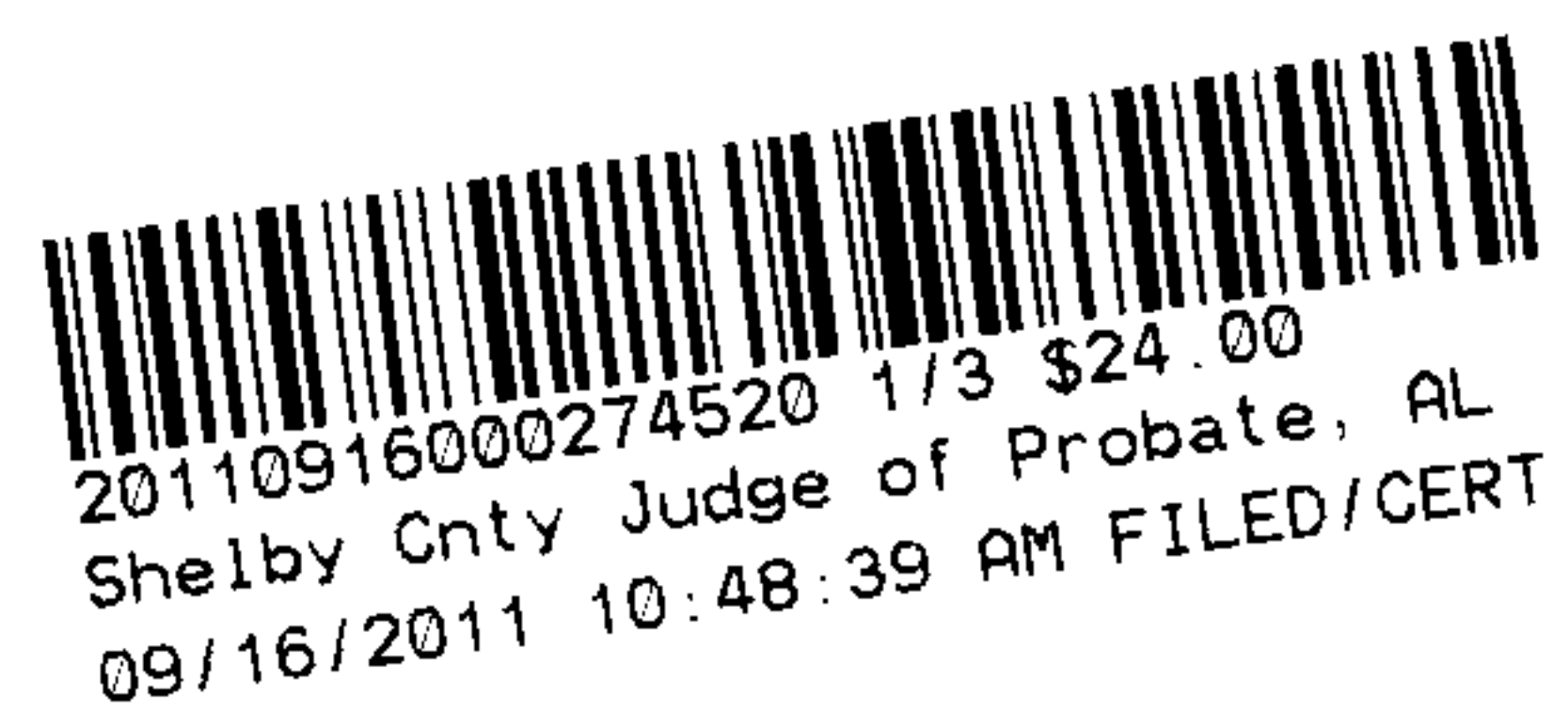
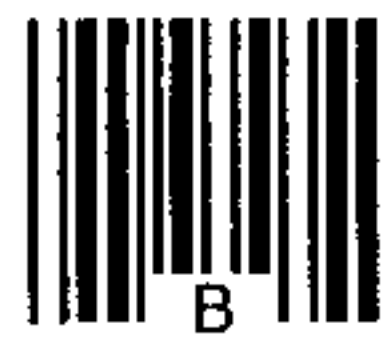

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of September, 2005, Robert W. Thomas, husband and wife, Karla Frances Sasser, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Henger Rast & Associates, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20051010000527950 corrected by scrivener's affidavit recorded in Instrument Number 20060623000302970, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument Number 20110708000198850, in the aforesaid Probate Office ("Transferee"); and

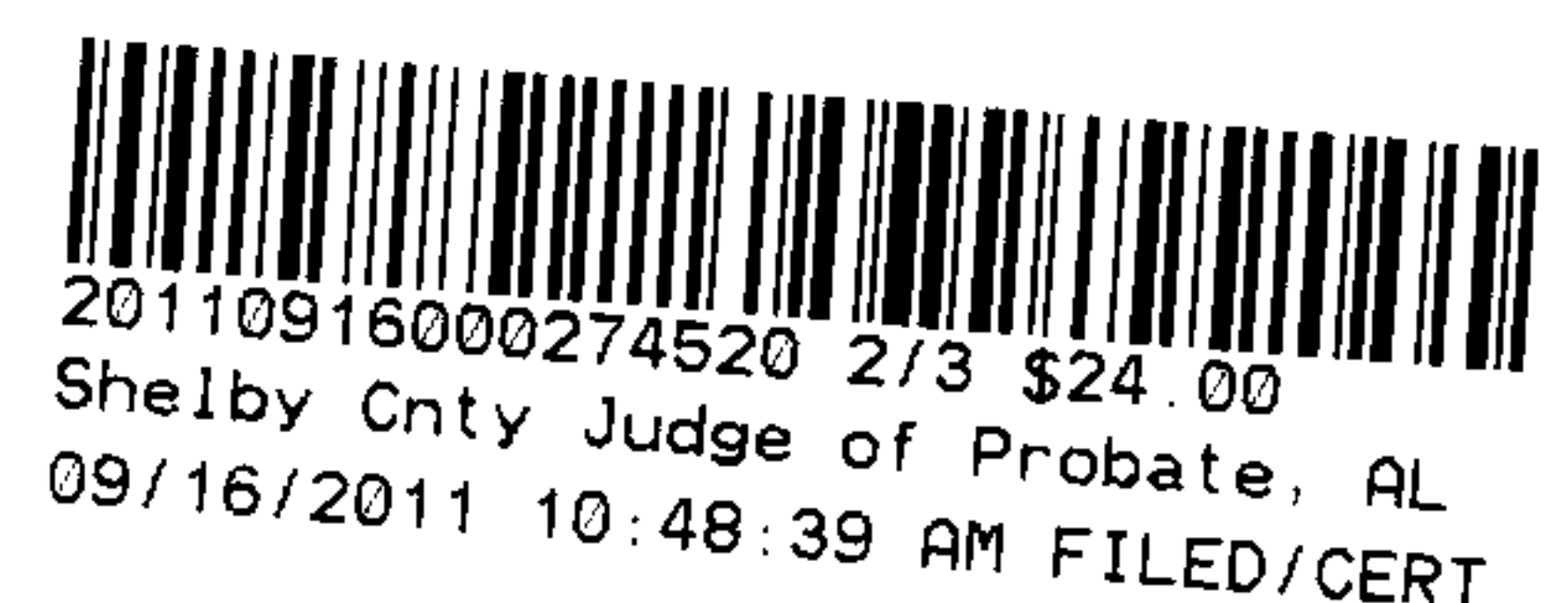
