- Article IV If there was no meeting, attach a statement that such amendment was adopted by written consent and signed by all members entitled to vote.
- Article V If there are no members or no members are entitled to vote, attach a statement indicating this fact, the date of the Board of Directors meeting at which the amendment was adopted, and that the amendment was adopted by the vote of a majority of the directors in office.

Pursuant to the provisions of the Alabama Non-profit Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.

Article I The name of the Corporation is Adopt A Golden Birmingham, Inc.

Article II The duration of the Corporation is perpetual.

Article III The Corporation has been organized to rescue and put up for adoption golden retrievers.

Article IV The Corporation has no members, and is a nonprofit corporation organized pursuant to the Alabama Non-profit Corporation Act and within meaning of Section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article V The initial registered Corporate office address is 3730 Chalybe Walk, Birmingham, Alabama 35226, and John Sellers is the initial registered agent at the corporate office.

Article VI The Corporation's initial Board of Directors are:

Article VII The Corporation is empowered to receive and accept donations, in money or in property, either without restrictions, or restricted in such purposes as the donor may specify, provided such purpose is within the purpose of the Corporation, and any such restricted donation shall be used for the purpose to which restricted.

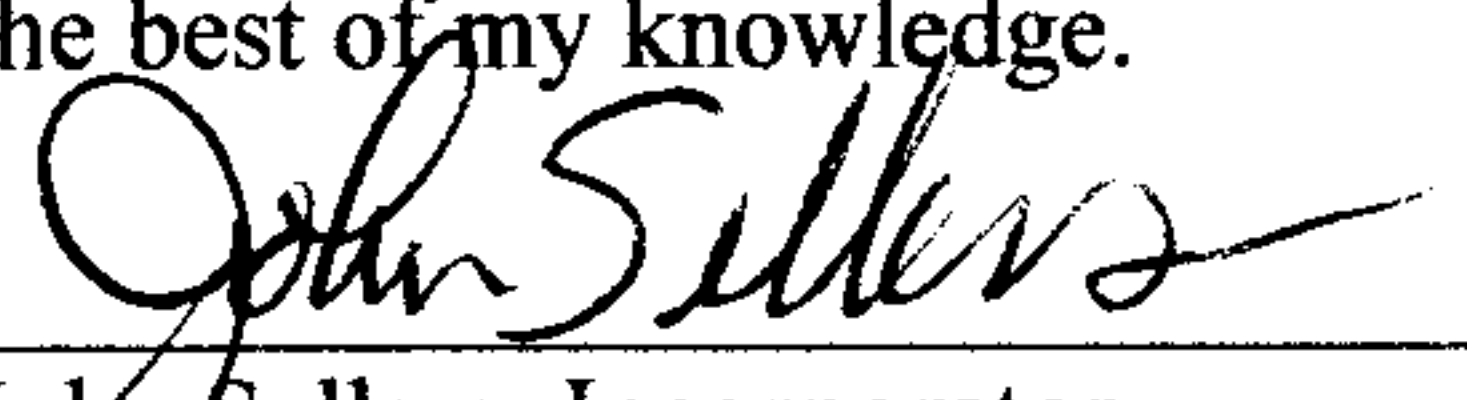
Article VIII The Corporation Board of Directors shall ethically govern and managed the affairs of the Corporation in compliance with the Corporation Bylaws.

Article IX Adopt A Golden Birmingham, Inc. is organized exclusively for charitable, educational purposes. Upon the dissolution of Adopt A Golden Birmingham, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
