

## ARTICLES OF ORGANIZATION

Pursuant to Section 10-21-1, Code of Alabama (1975) et seq., the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

## ARTICLE I - NAME

The Name of the Limited Liability Company shall be International Adoption Medical Specialists, LLC (the "Company").

#### ARTICLE II - <u>DURATION</u>

The period of duration of the Company shall be perpetual, unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act").




