LIMITED POWER OF ATTORNEY

This Limited Power of Attorney is made as of November 4, 2011 by LEX Special Assets, LLC with an office at c/o Lehman Brothers Holdings Inc. 1271 Avenue of the Americas, New York, NY 10020 ("Owner"), in favor of Green River Capital, LC by and through Green River Capital's officers, as Owner's attorney-in-fact, in Owner's name, place and stead in connection with the real property commonly known as **4734 HOLLOW LN, HELENA, AL 35080** ("Real Property") for the limited purpose of performing such acts and executing and delivering such documents and other instruments in the name of Owner as may be necessary or desirable to effectuate the following transactions concerning the Real Property:

- 1) to execute, acknowledge, seal and deliver any and all documents, deeds (such deeds to be without recourse), transfers, tax declarations, certificates, escrow instructions, bills of sale, closing statements and any other documents or instruments whatsoever which are necessary, appropriate, or required to transfer and assign the Real Property to Seung H Chung pursuant to a Purchase and Sale Agreement between Owner and Seung H Chung dated 10/27/11.

As between Owner and Green River Capital, LC, this Limited Power of Attorney shall be effective as of the date first written above, and shall remain in full force and effect thereafter until a written notice of revocation hereof shall have been executed by Owner, provided that in no event will Green River Capital, LC be authorized to act for and on behalf of Owner in the event that the Agreement has been terminated. Until a properly executed revocation of this Limited Power of Attorney is duly executed and delivered or the Agreement has been terminated, all parties dealing with Green River Capital, LC in connection with the above-described matters may fully rely upon the power and authority of Green River Capital, LC to act for and on behalf of Owner, and in its name, place and stead, and may accept and rely on all documents and agreements entered into by Green River Capital, LC a pursuant to the powers listed herein. Third parties without actual notice may rely upon the exercise of the power granted under this Limited Power of Attorney and may be satisfied that this Limited Power of Attorney shall continue in full force and effect and has not been revoked unless an instrument of revocation has been made in writing by the undersigned or the Agreement has been terminated. This appointment is to be construed and interpreted as a limited power of attorney with respect to the Real Property described above. The enumeration of specific items, rights, acts or powers herein is not intended to, nor does it give rise to, and it is not to be construed as a general power of attorney. To the extent that Green River Capital, LC has taken any action otherwise consistent with the powers granted herein prior to the effective date hereof, Owner hereby ratifies and confirms all such actions the same as if Owner had taken such action itself.

Nothing in this Limited Power of Attorney shall be construed to prevent Owner from acting on its behalf as the Owner of the Real Property. This Limited Power of Attorney is entered into and shall be governed by the laws of the State of New York without regard to conflicts of law principles thereof.
