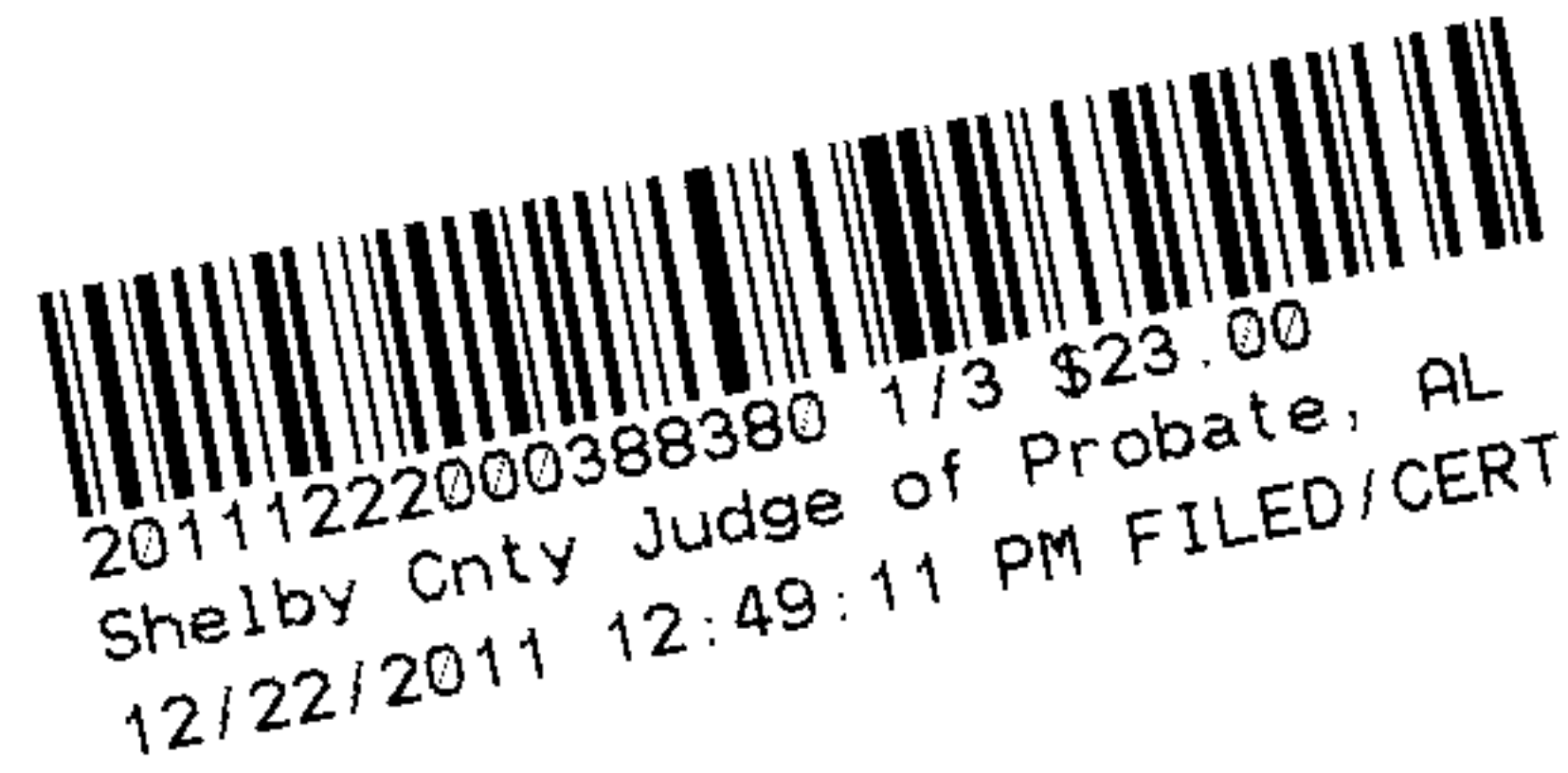

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that,




