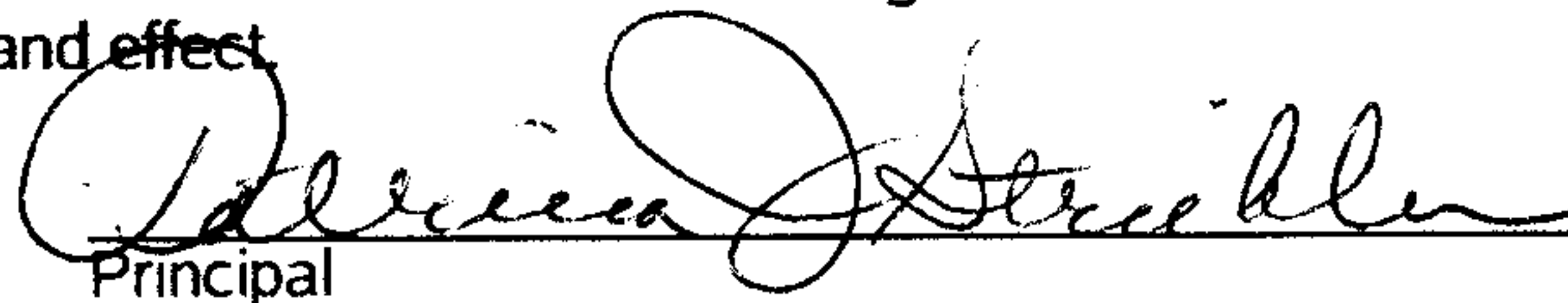
KNOW ALL MEN BY THESE PRESENTS:

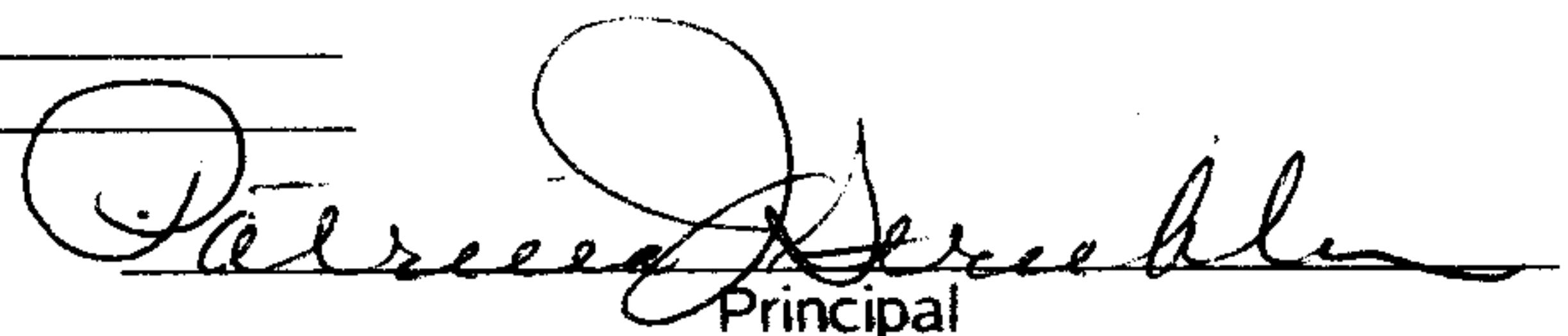
OATH OF OFFICE

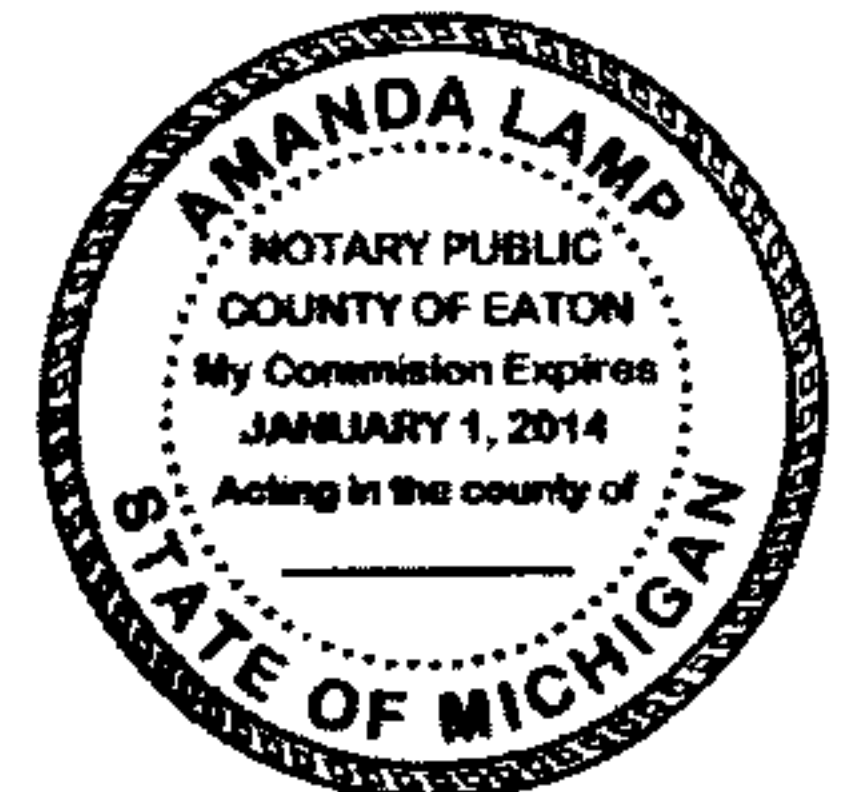

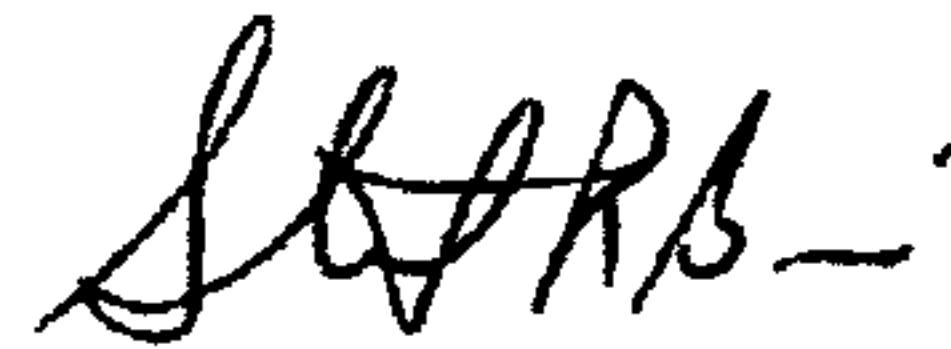
