**ARTICLES OF ORGANIZATION
OF
Lunaseay, LLC**

The undersigned, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certify as follows:

1. **Name.** The name of the entity is Lunaseay, LLC.
2. **Type of Entity.** The type of entity being formed is a limited liability company.
3. **Purpose.** The purposes for which this limited liability company is organized are to purchase, hold, sell, improve and lease real property and mortgage and encumber the same and to erect, manage, care for and maintain, extend and alter buildings thereon, and to engage in the transaction of any and all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.
4. **Duration.** The existence of the limited liability company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Law.
5. **Registered Agent and Registered Office.** The location and mailing address of the initial registered office shall be 141 Kings Crest Lane, Pelham, Alabama 35124, and the name of the initial registered agent at said address shall be James Rodney Seay.
6. **Initial Members.** The names and mailing addresses of the initial members of the limited liability company are as follows:


