ARTICLES OF ORGANIZATION

OF

I, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, hereby certify and adopt the following Articles of Organization:

- 1. The name of the Limited Liability Company is Milster Consulting Group, LLC.
- 2. The purpose for which this Limited Liability Company is organized is:

The members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company if there are at least one (1) remaining member.
- 8. Management of the Limited Liability Company shall be vested exclusively in its members, who shall vote according to their proportionate interests in the company.


