IN WITNESS WHEREOF, the Assignor, acting by its duly authorized managing partner has signed, sealed and delivered this Assignment on the date above written.

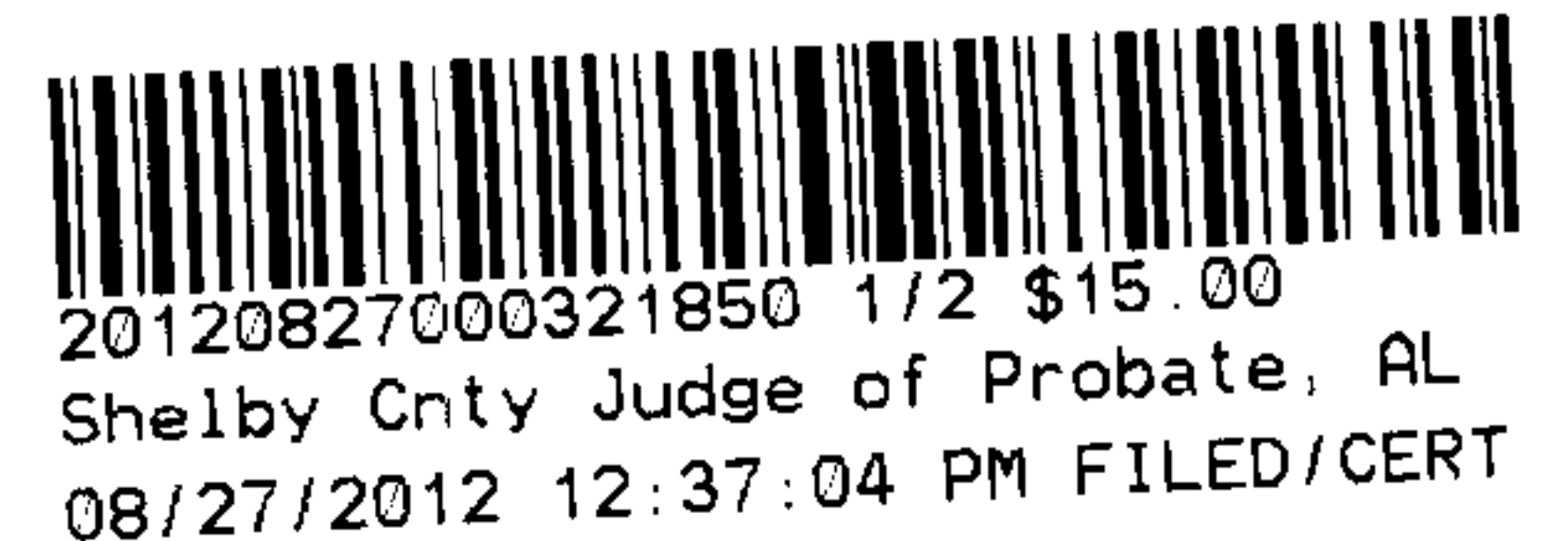

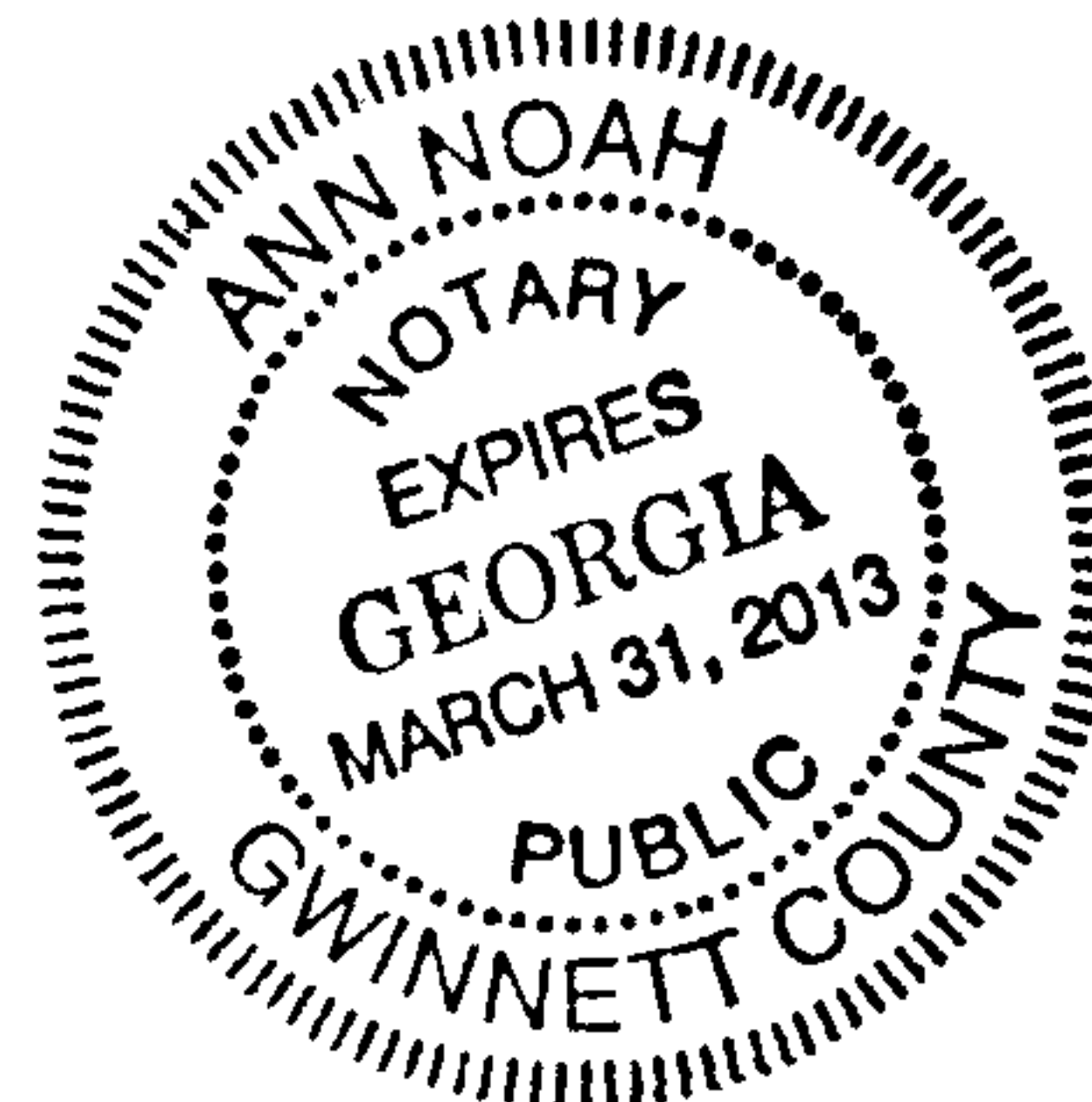
