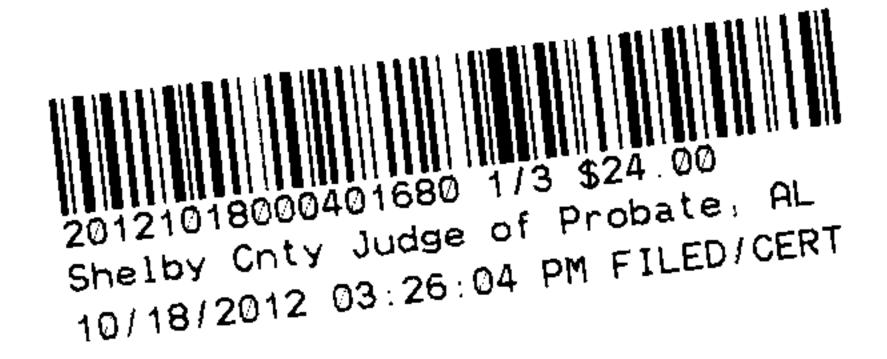
#### **AUCTIONEER'S DEED**



# STATE OF ALABAMA COUNTY OF SHELBY

WHEREAS, JOSHUA COWAN and ISABELLA COWAN, Husband and Wife executed a mortgage to Mortgage Electronic Registration Systems, Inc.
