Willis (herein referred to as grantors) do grant, bargain, sell and convey unto Aaron C. Pearson and Amy N. Pearson, husband and wife (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:



Subject to taxes for 2012 and subsequent years, easements, restrictions, rights of way, and permits of record.




