That in consideration of **Two Hundred Thirty-Two Thousand Seven Hundred Fourteen and 00/100 Dollars (\$232,714.00)** and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof are acknowledged,

**D.R. Horton, Inc. - Birmingham**

(herein referred to as GRANTORS, whether one or more) does, grant, bargain, sell and convey unto

**Wayne T. Nichols and Rebecca Nichols**

(herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in SHELBY County, Alabama, to-wit:

**Lot 243, according to the Final Record Plat of Creekside Phase 2, Part B, as recorded in Map Book 39, page 58, in the Probate Office of Shelby County, Alabama.**

Mineral and mining rights excepted. Subject to current taxes, conditions, covenants, easements and restrictions of record. \$186,171.00 of the consideration was paid from a mortgage loan closed simultaneously herewith.

This covenant and agreement shall run with the land conveyed hereby as against Grantees, and all persons or entities holding under or through Grantees.

Grantor makes no warranty or covenant respecting the nature of the quality of the title to the property hereby conveyed other than that the Grantor has neither permitted or suffered any lien, encumbrance or adverse claim to the property described herein since the date of acquisition thereof by the Grantor.

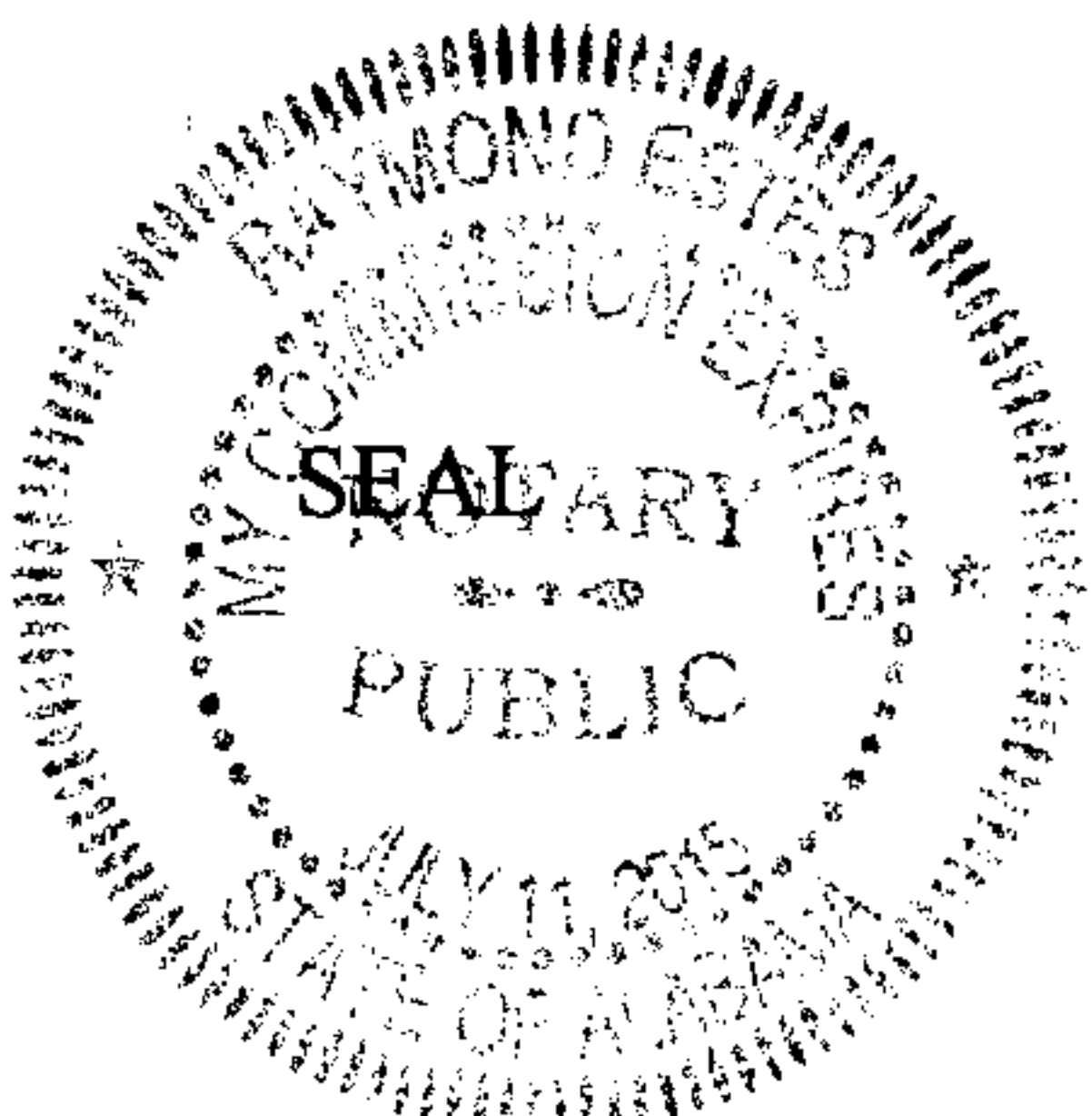



