



#### OPERATING AGREEMENT CHILTON COUNTY BAIL BONDS, LLC November 29, 2012

- 1. Hiring or firing of agents to be approved by both Owners.
- 2. Agents' commission percentage to be approved by both Owners.
- 3. Death of either Owner will result in deceased Owner's 50% of business to transfer to remaining Owner.
