Situated in Shelby County, Alabama.



Subject to taxes for 2013 and subsequent years, easements, restrictions, rights of way, and permits of record.



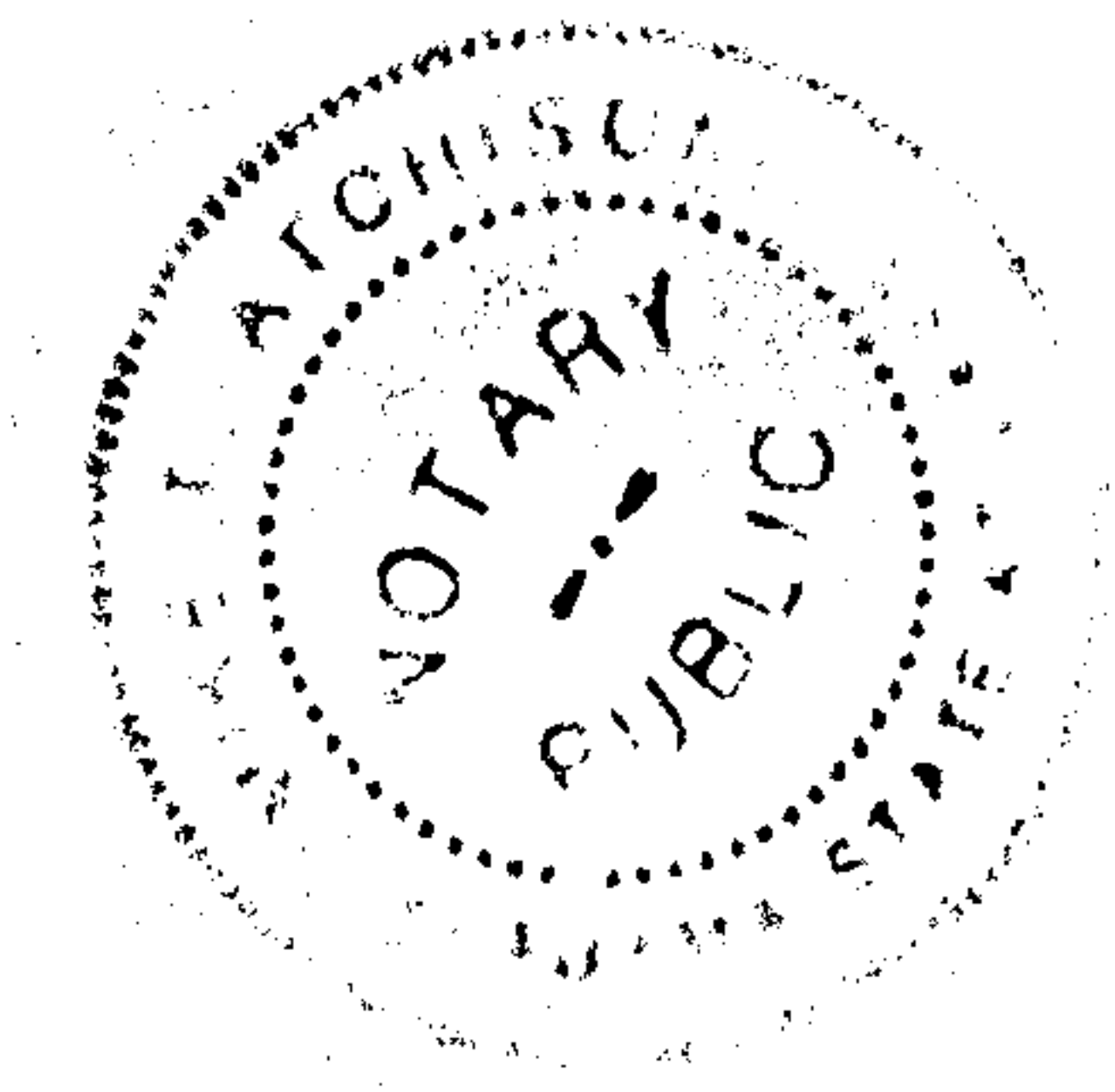
