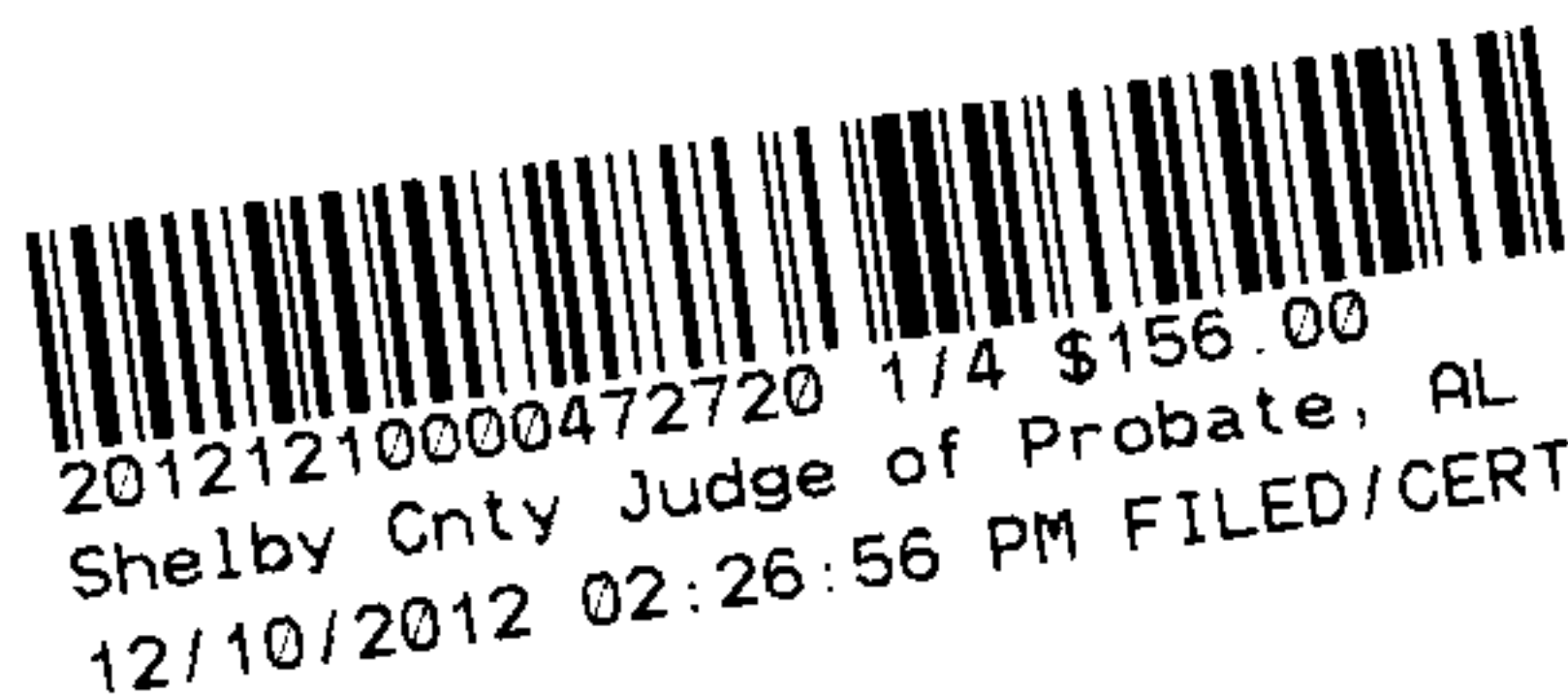

**ARTICLES OF ORGANIZATION
OF
LANDSEARCHUSA.COM, LLC**

AN ALABAMA LIMITED LIABILITY COMPANY

Pursuant to the provisions of the Alabama Limited Liability Company Act, as set forth in Sections 10-12-1, *et seq.* of the *Code of Alabama* (1975), as amended from time to time (the "Act"), the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

ARTICLE I

Name

The name of the limited liability company is LANDSEARCHUSA.COM, LLC (the "Company").

ARTICLE II

Duration

The Company shall have a duration from the date of organization until it is dissolved and its affairs are wound up in accordance with the Act or the Company's Operating Agreement.

ARTICLE III

Purposes

The objects and purposes for which the Company is formed are:

- (a) To engage in the ownership, rental, and leasing of warehouse and storage facilities;
- (c) To engage in any and all transactions and activities necessary, appropriate, customary, convenient or incidental to any of the foregoing purpose, and to exercise all powers necessary to, or reasonably connected with the Company's business described above, which may be legally exercised by limited liability companies under the Act; and
- (d) To engage in any other lawful act or activity which all of the members consent to in writing.

ARTICLE IV

Registered Office; Registered Agent

The location and mailing address of the initial registered office of the Company shall be 2701 Pelham Parkway, Pelham, Alabama, Alabama 35124, and its registered agent at such address shall be Christopher Borgosz.

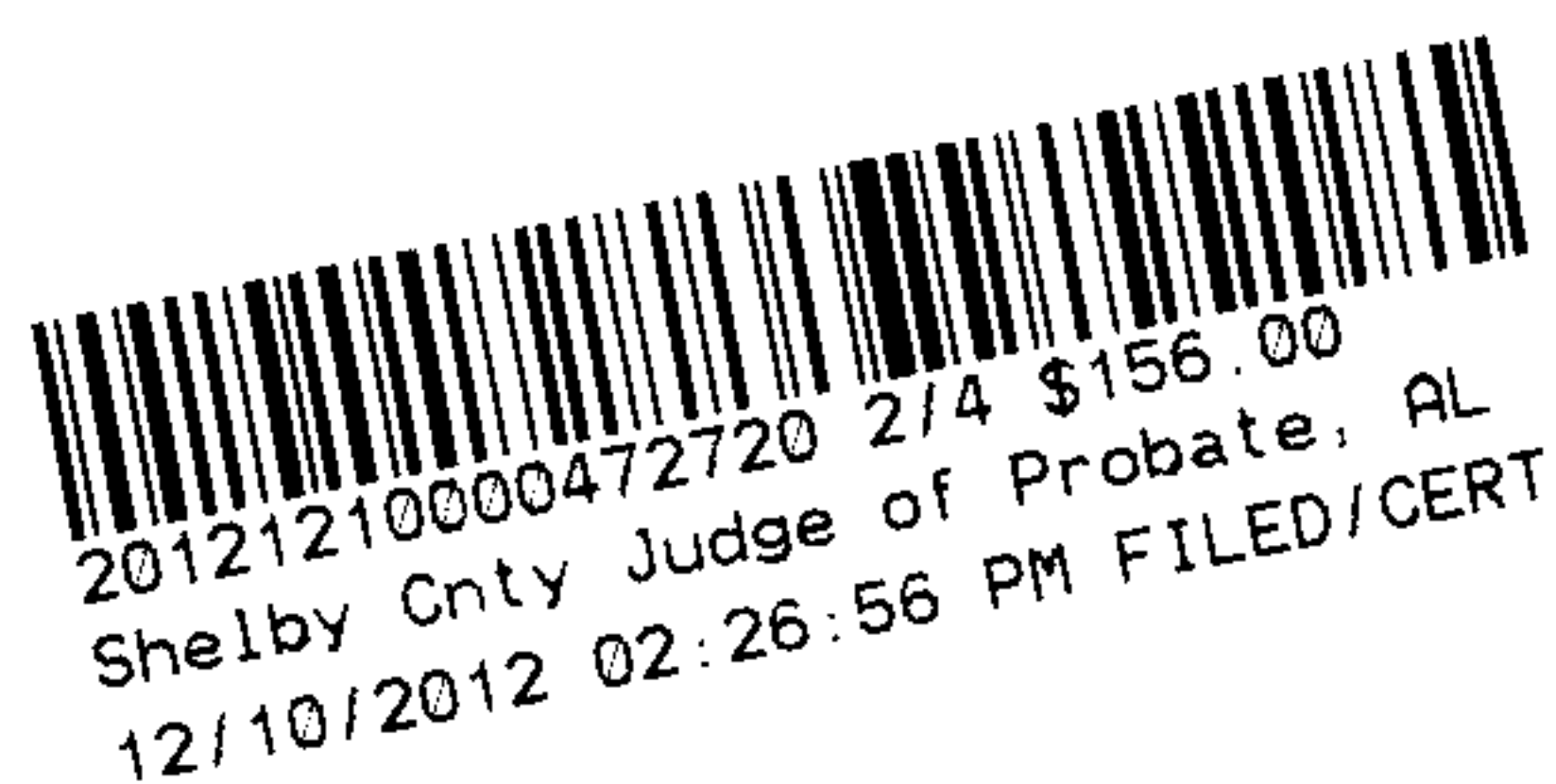
ARTICLE IX

Effect of Cessation of Membership


The only circumstances under which the cessation of membership of one or more members will result in the dissolution of the Company is when such cessation leaves no remaining member and there are no members going forward, unless either of the following applies:

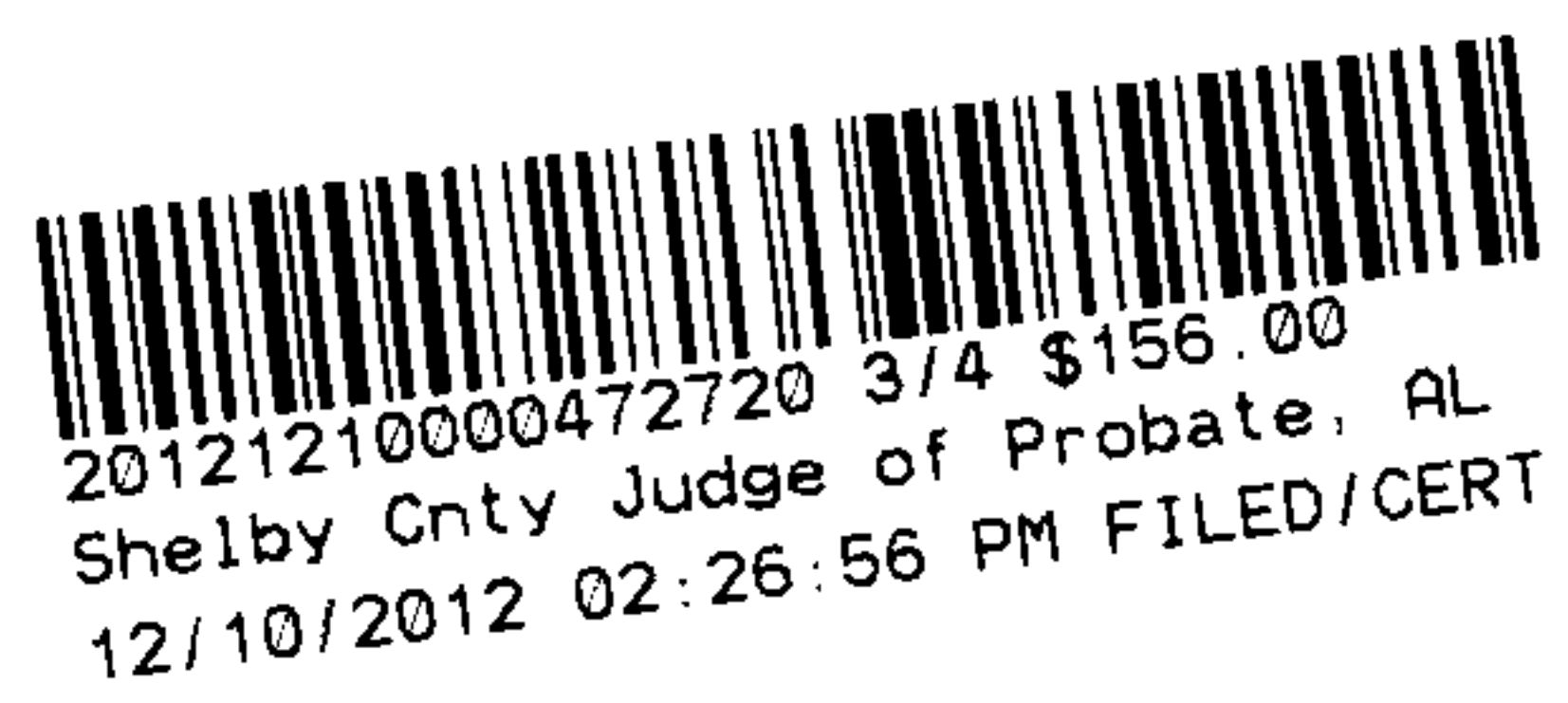
(i) the holders of all of the financial rights in the Company agree in writing, within ninety (90) days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members; or

(ii) the legal existence and business of the Company is continued and one or more new members are appointed as members in the manner, if any, as may be stated in the Company's Operating Agreement.
