\$255,102.00 of the consideration was paid from a mortgage loan closed simultaneously herewith.


**TO HAVE AND TO HOLD**, unto the said GRANTEE her heirs and assigns forever

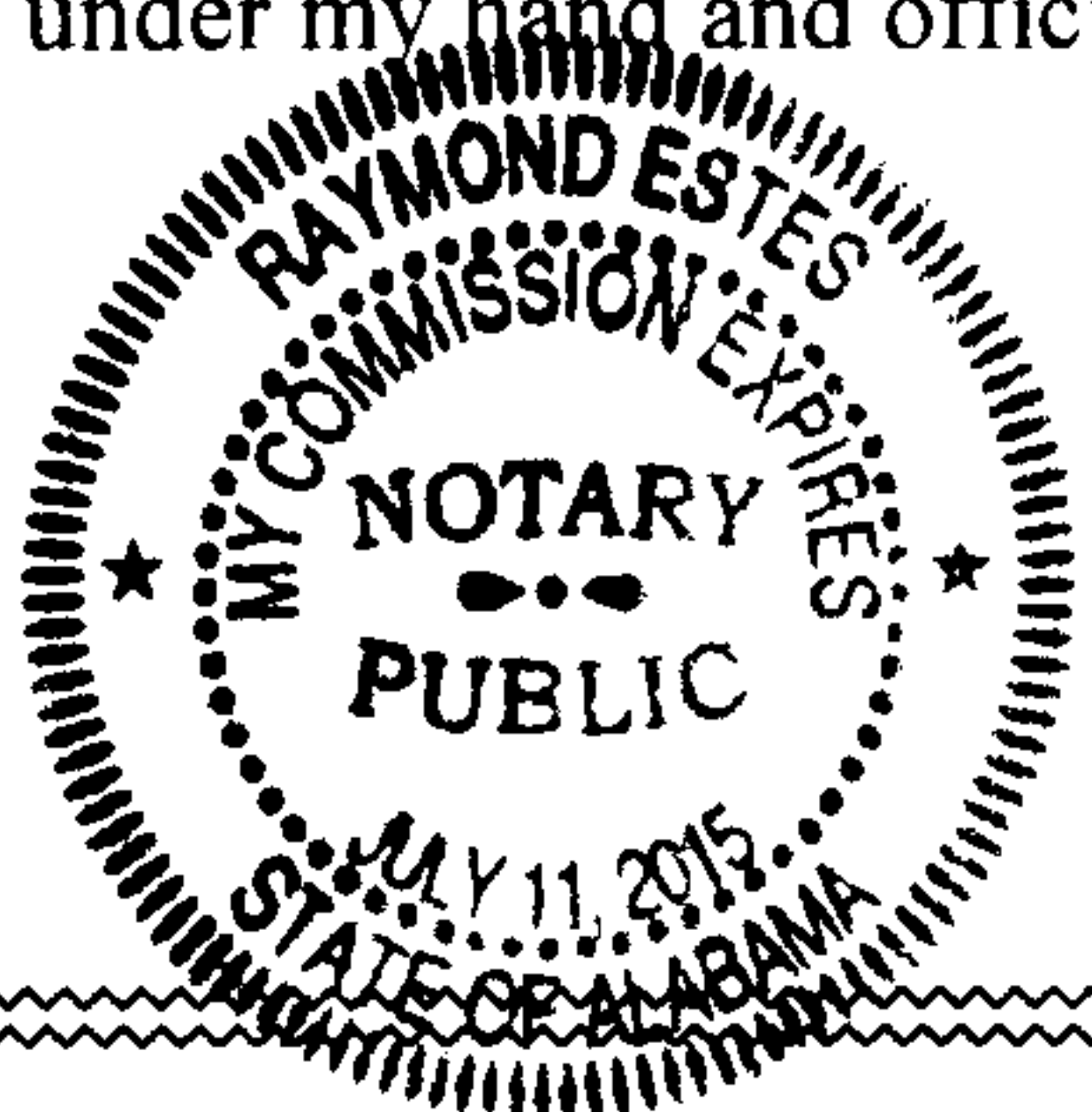
