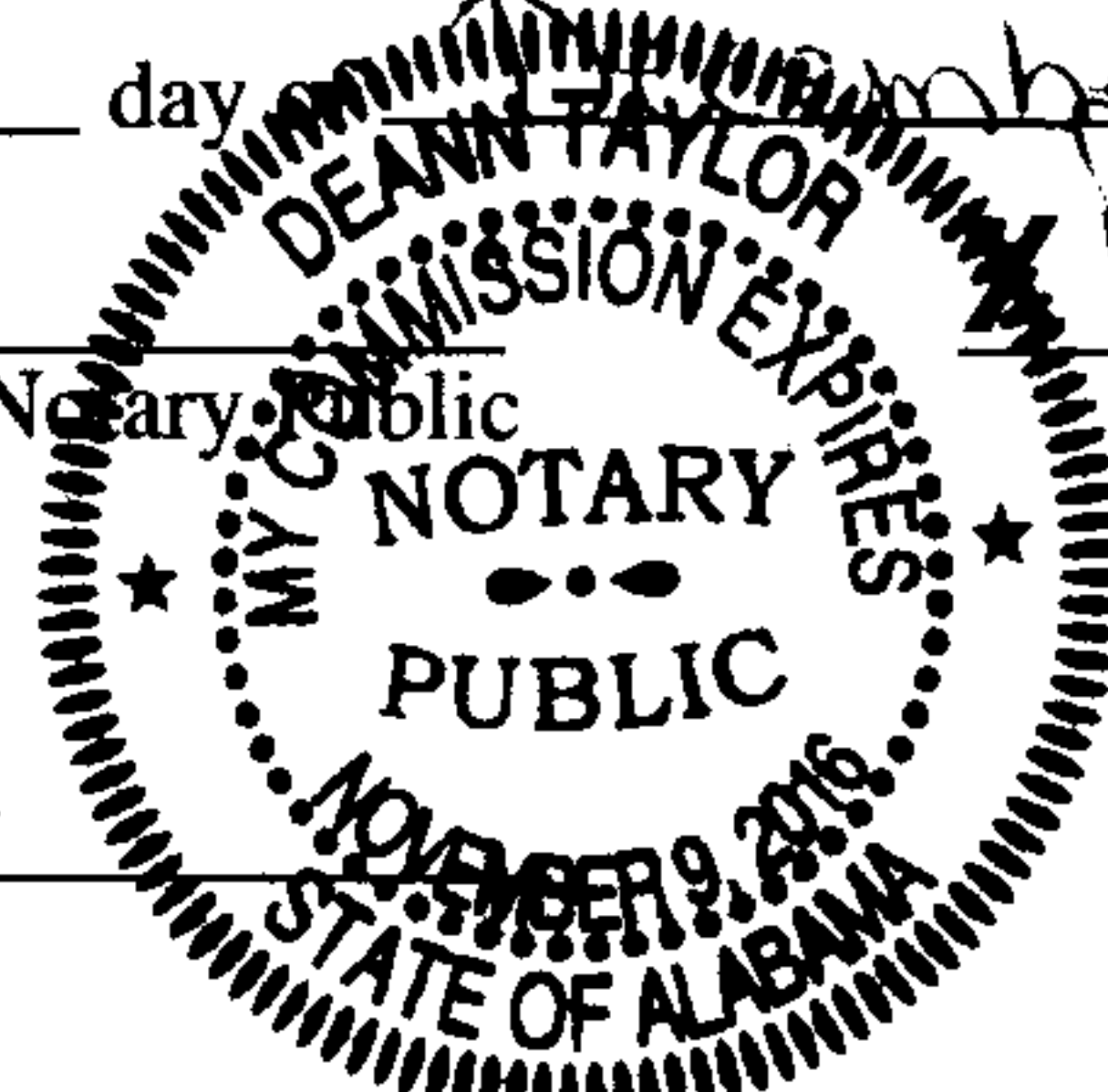
### Oath of Office

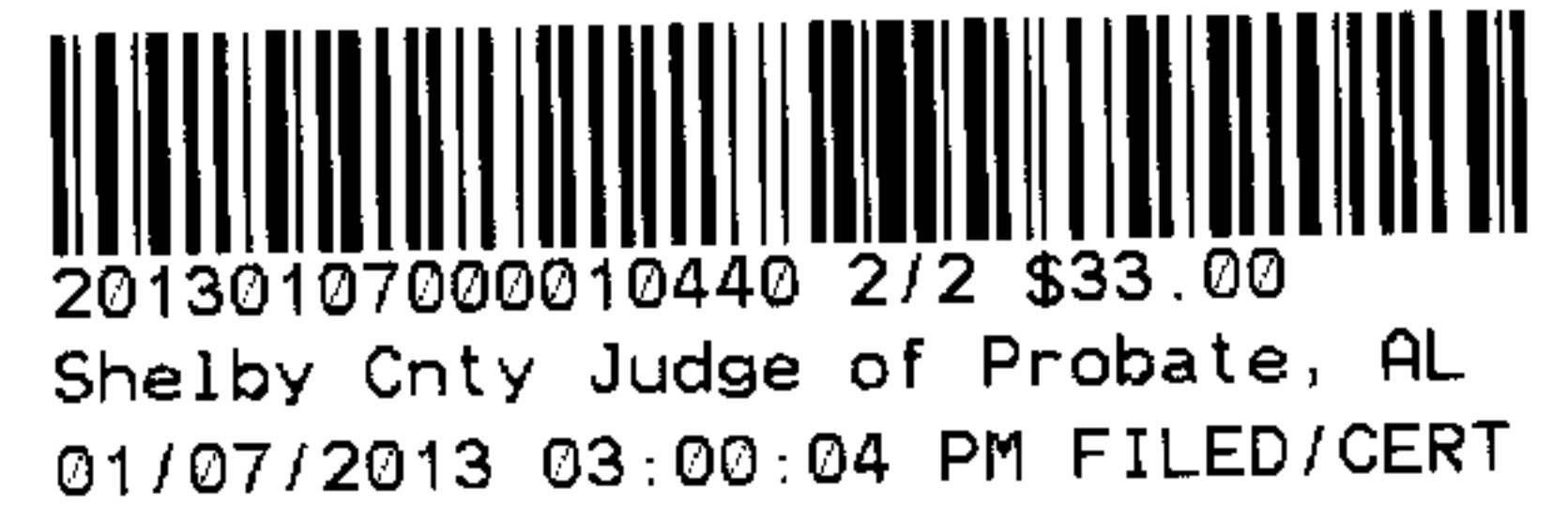

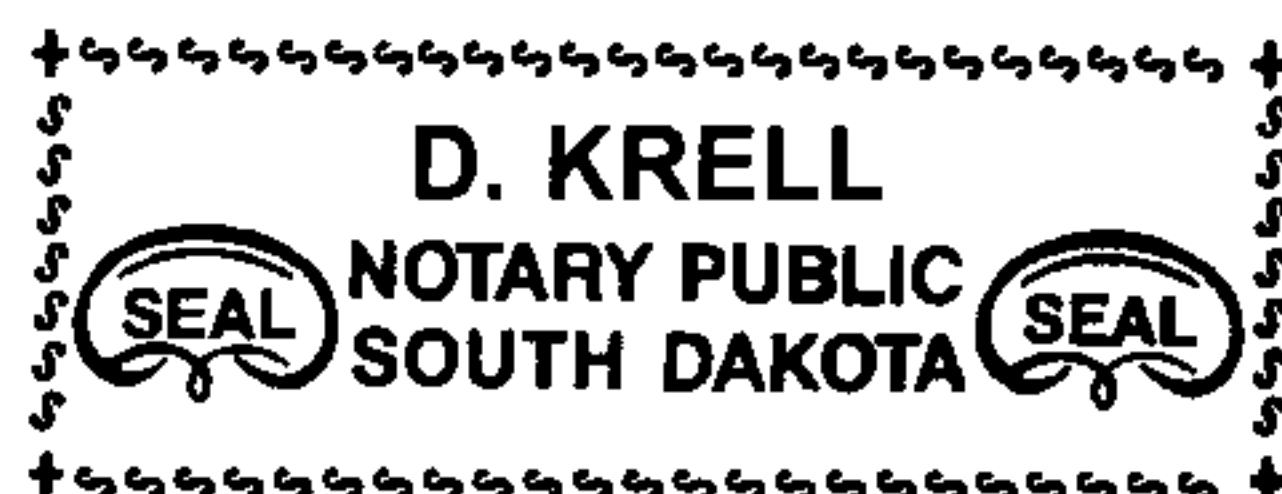
