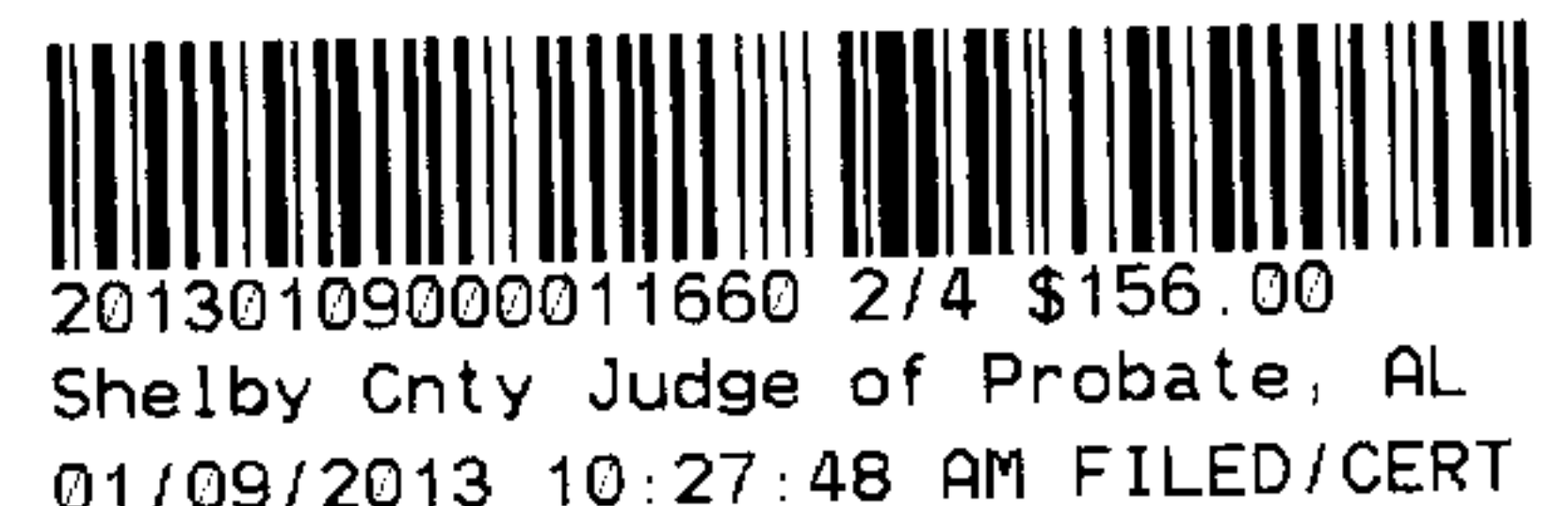

ARTICLE TEN


