\$90,392.00 of the consideration was paid from a mortgage loan closed simultaneously herewith.


**TO HAVE AND TO HOLD**, unto the said GRANTEE, her/his heirs and assigns forever.

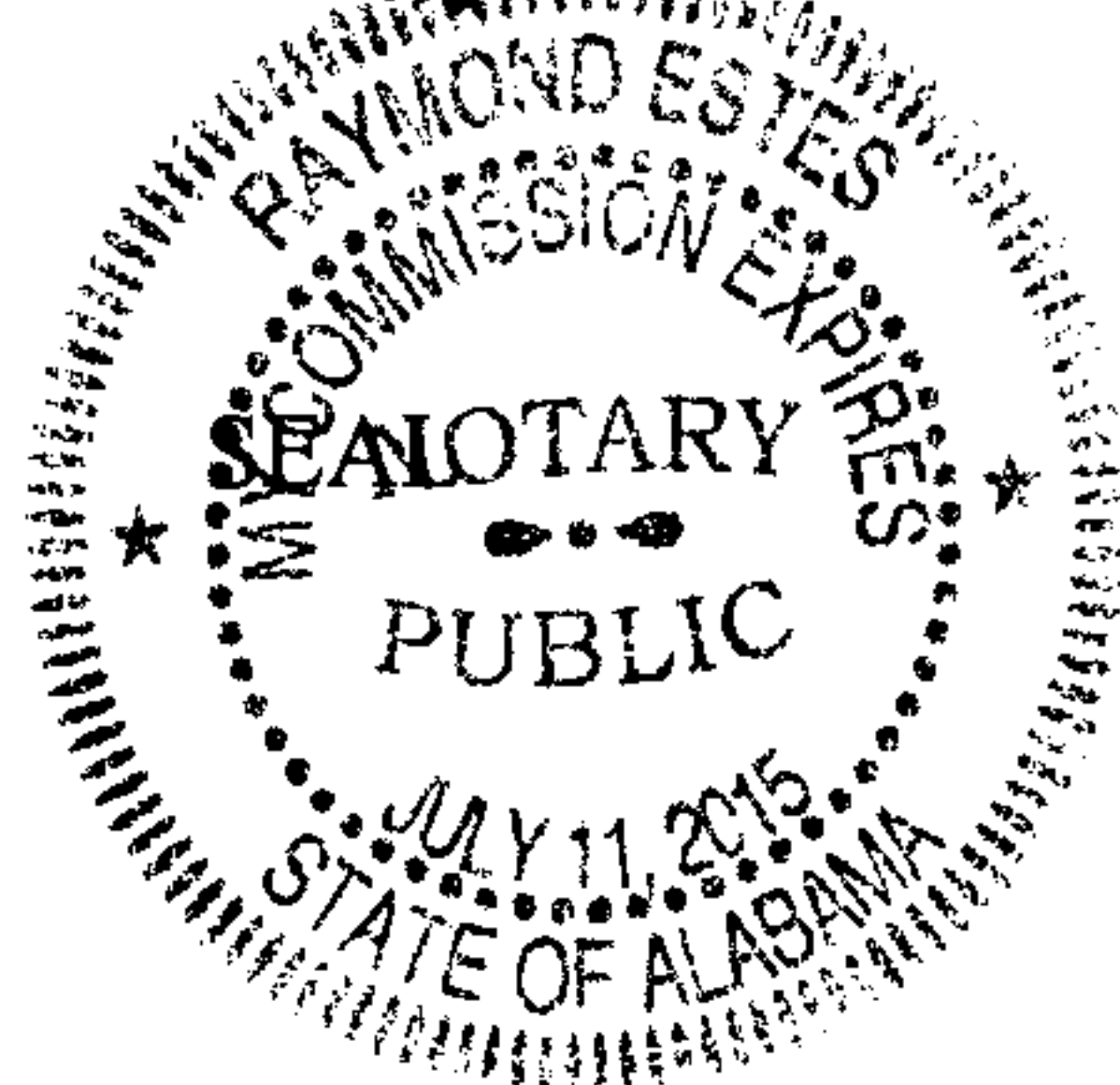
