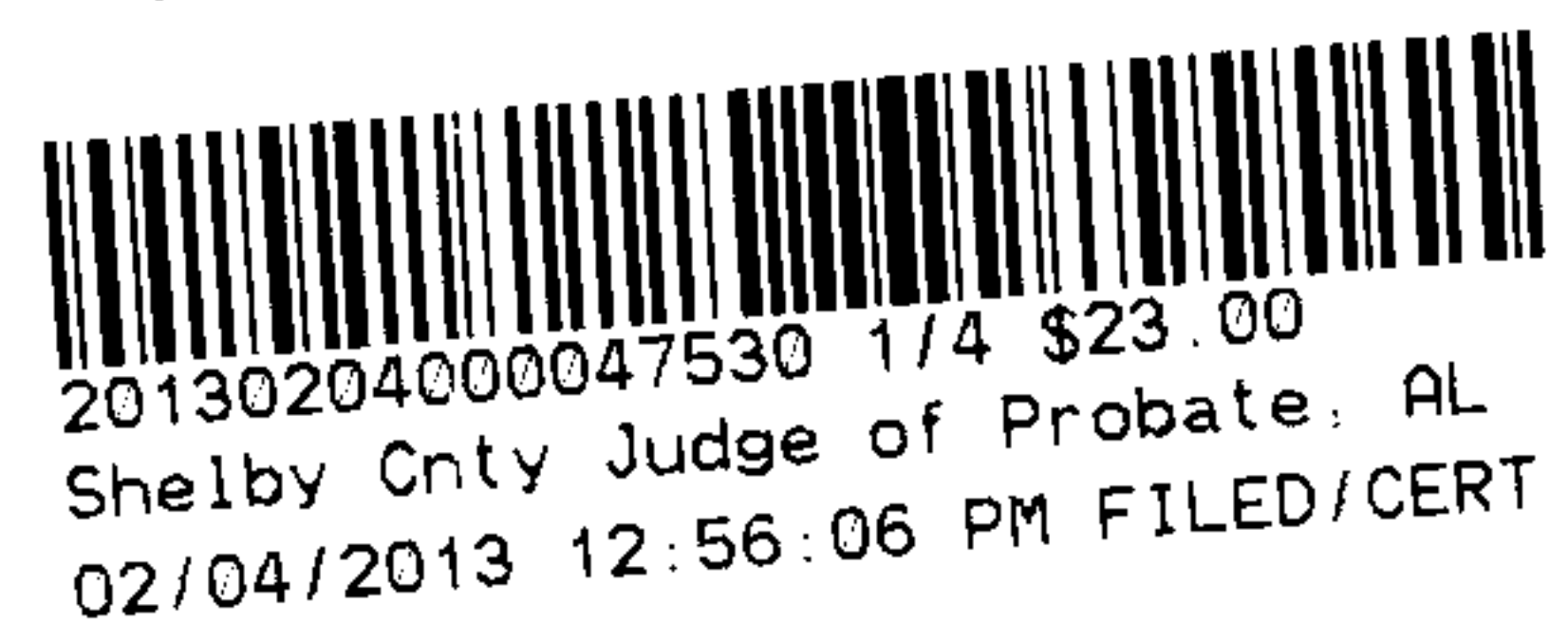
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 17th day of May, 2007, Christopher Ndei Kaibarare and Dorcas Ndei, husband and wife, executed that certain mortgage on real property hereinafter described to National City Mortgage, A Division of National City Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20070525000245450, and


