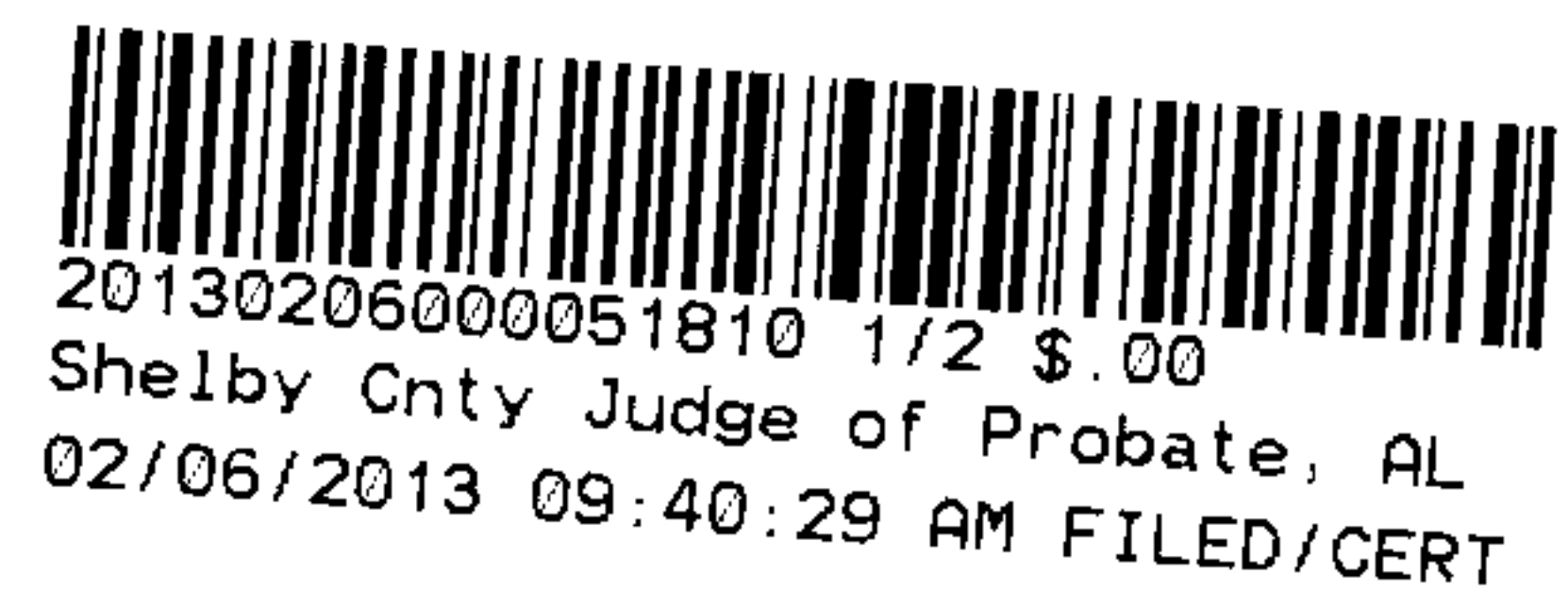


## NOTARY BOND

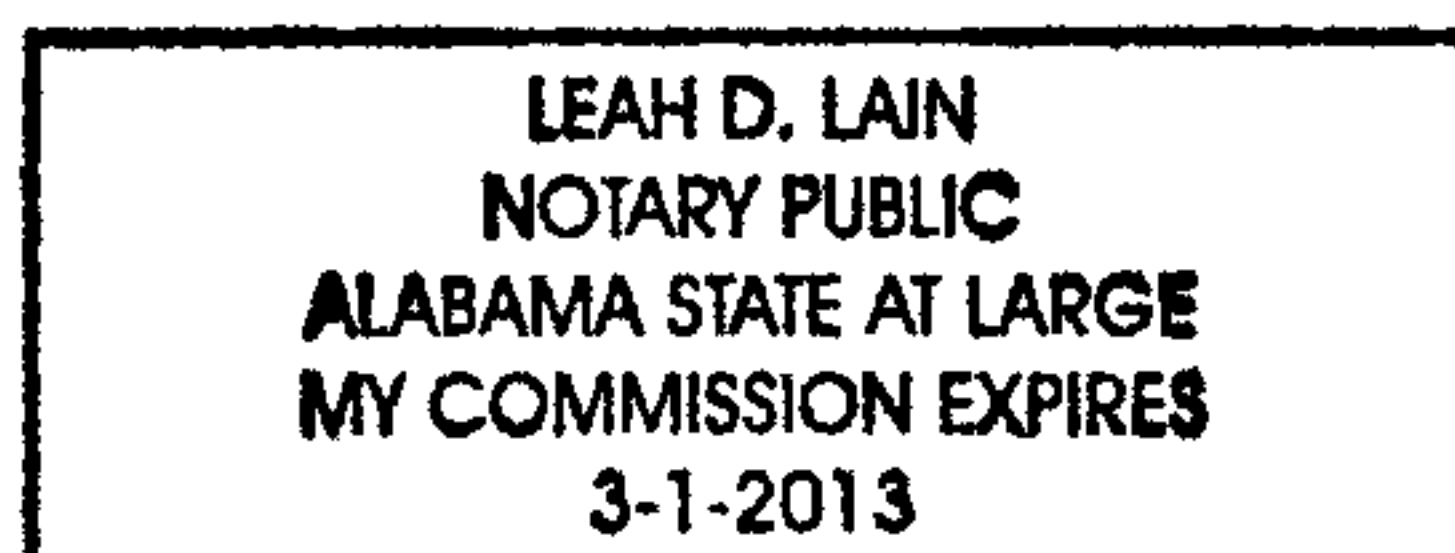
## OATH OF OFFICE

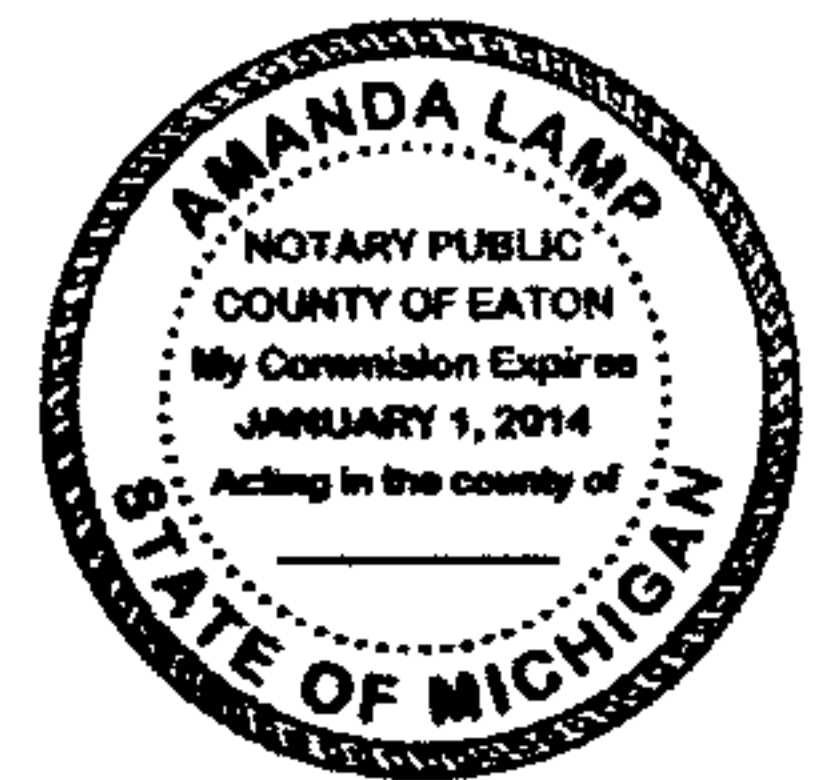


