FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on February 11, 2009, to-wit: Nicholas N. Wilson and Valerie L. Wilson, husband and wife, as joint tenants with right of survivorship, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for Community First Bank, a Federal Savings Bank, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on 03/02/2009, in Instrument Number 20090302000072690, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, National Association, by assignment recorded 11/08/2011, and recorded in Instrument Number 20111108000336290, Probate Records of Shelby County, Alabama; and

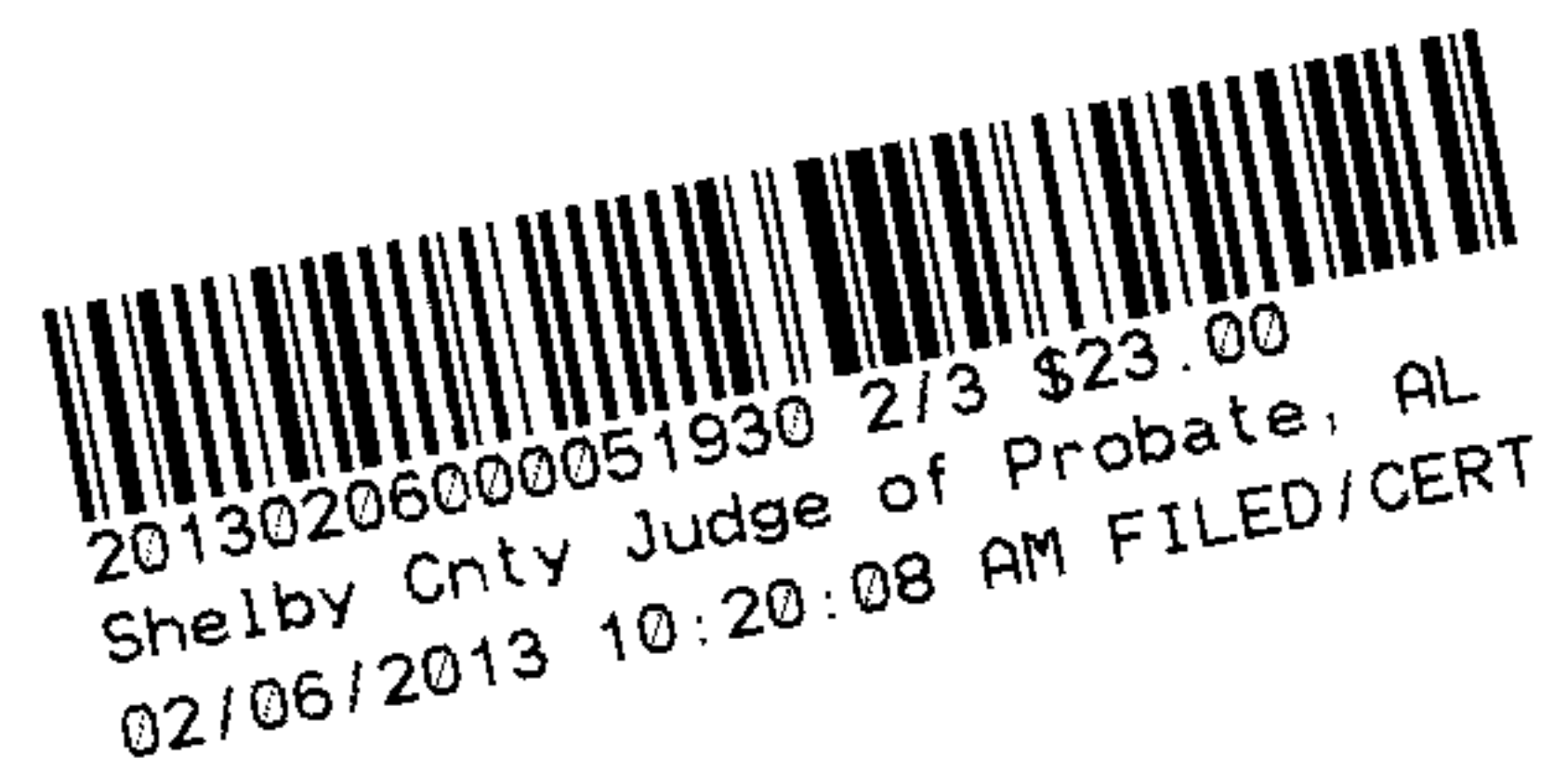
