KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of January, 2009, Joseph J. Robinson and Jessica A. Robinson, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for New South Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20090127000025750, said mortgage having subsequently been transferred and assigned to EverBank, by instrument recorded in Instrument Number 20121024000409300, in the aforesaid Probate Office ("Transferee"); and
