KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 11th day of February, 2009, Margaret Williams, A/K/A Margaret Ann Williams, an unmarried person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for MortgageAmerica, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20090305000081180, said mortgage having subsequently been transferred and assigned to PNC Bank, National Association, by instrument recorded in Instrument Number: 20120830000328210, in the aforesaid Probate Office ("Transferee"); and


