LOAN MODIFICATION AGREEMENT TO THE MORTGAGE



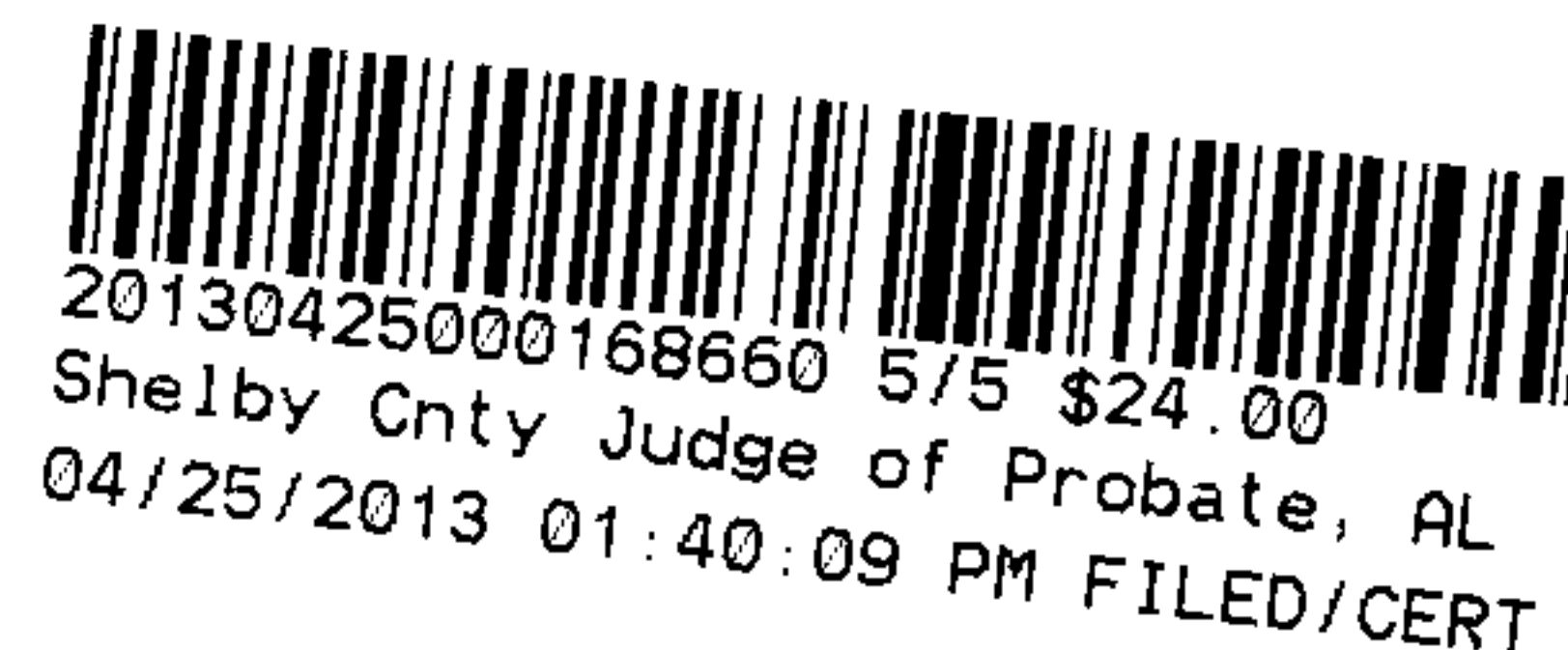
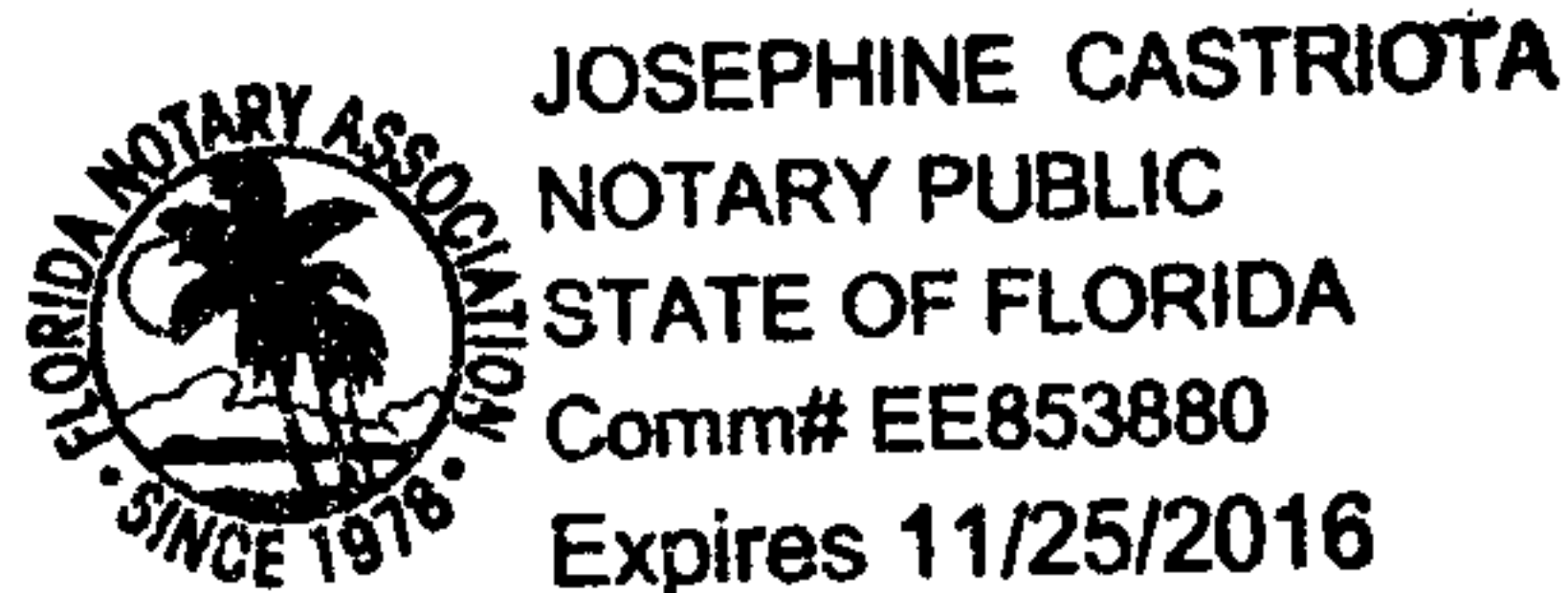
