- 1. The name of the company is Tiffany Cove Homeowners Association, Inc.
- 2. The Alabama Entity ID Number is 565-273.
- 3. The effective date the Articles of Dissolution was filed was December 26, 2012.
- 4. The revocation of dissolution was authorized in the same manner as the dissolution on April 1, 2012.
- 5. The revocation of dissolution was unanimously approved by the shareholders. The number of votes entitled to be cast on the proposed revocation was 1. The total number of votes cast for dissolution was 1 and the total number of votes cast against dissolution was 0.
- 6. The Articles of Revocation are effective on the date this document is recorded in the Office of the Judge of Probate and relate back to and take effect as of the effective date of the dissolution and the corporation resumes carrying on its business as if dissolution had never occurred


