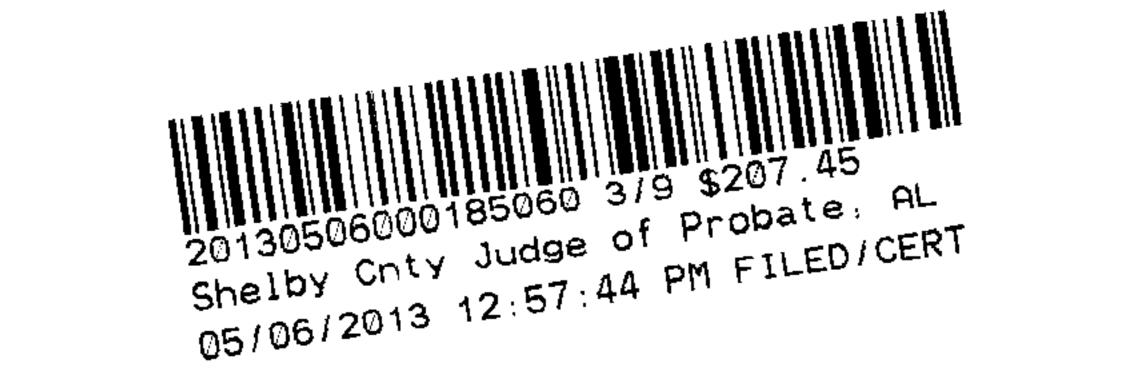

#### LOAN MODIFICATION AGREEMENT

This Loan Modification Agreement (the "Agreement"), made on August 20, 2011 between AMY WINDHAM (the "Borrower(s)") and Bank of America, N.A. All capitalized terms not defined herein shall have the same meanings as set forth in the Security Instrument.

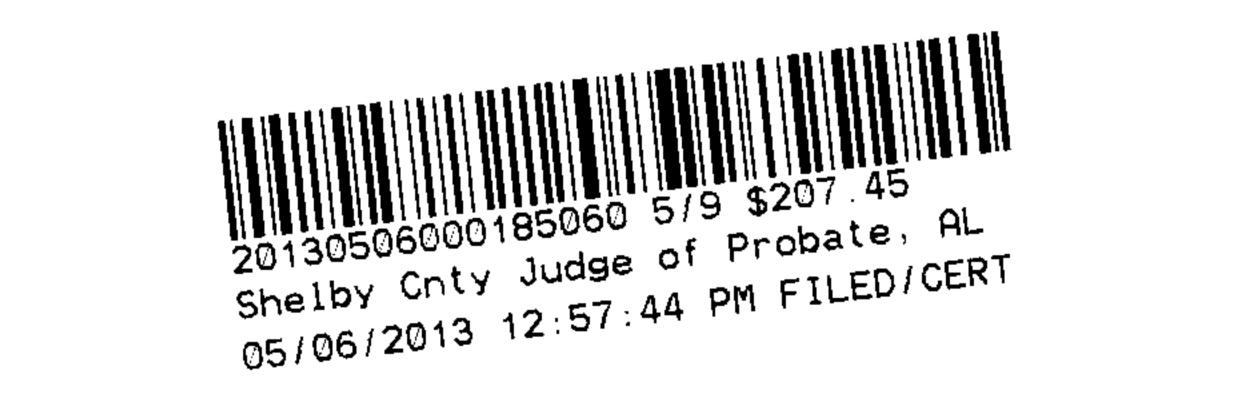

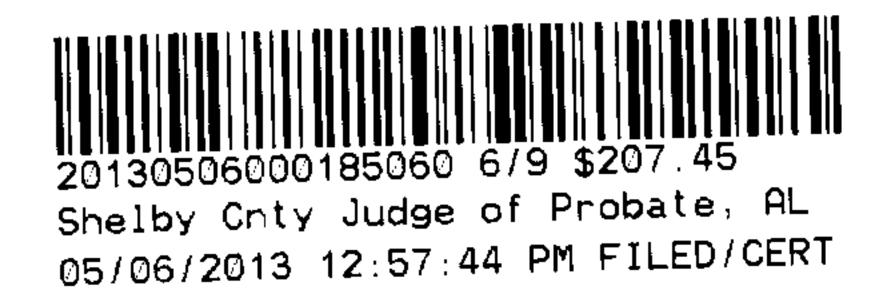
