**SPECIAL WARRANTY DEED**

That in consideration of One Hundred Thousand Five Hundred And 00/100 (\$100,500.00) to the undersigned, Fannie Mae a/k/a Federal National Mortgage Association, a corporation, by and through Sirote & Permutt, P.C., as Attorney in Fact, (herein referred to as Grantor) in hand paid by the Grantee herein, the receipt whereof is acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Jerry Adams, (herein referred to as Grantee), the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 60, according to the Survey of Wyndham, Camden Sector, as recorded in Map Book 22, Page 93 in the Probate Office of Shelby County, Alabama.

Subject to:

1. Any item disclosed on that certain policy of title insurance obtained in connection with this transaction.
2. Ad valorem Taxes for the current tax year, which Grantee herein assume and agree to pay.
3. Restrictive covenant as recorded in Instrument No. 1997-16429 and Instrument Number 1997-29516.
4. Restrictions as shown on recorded plat.
