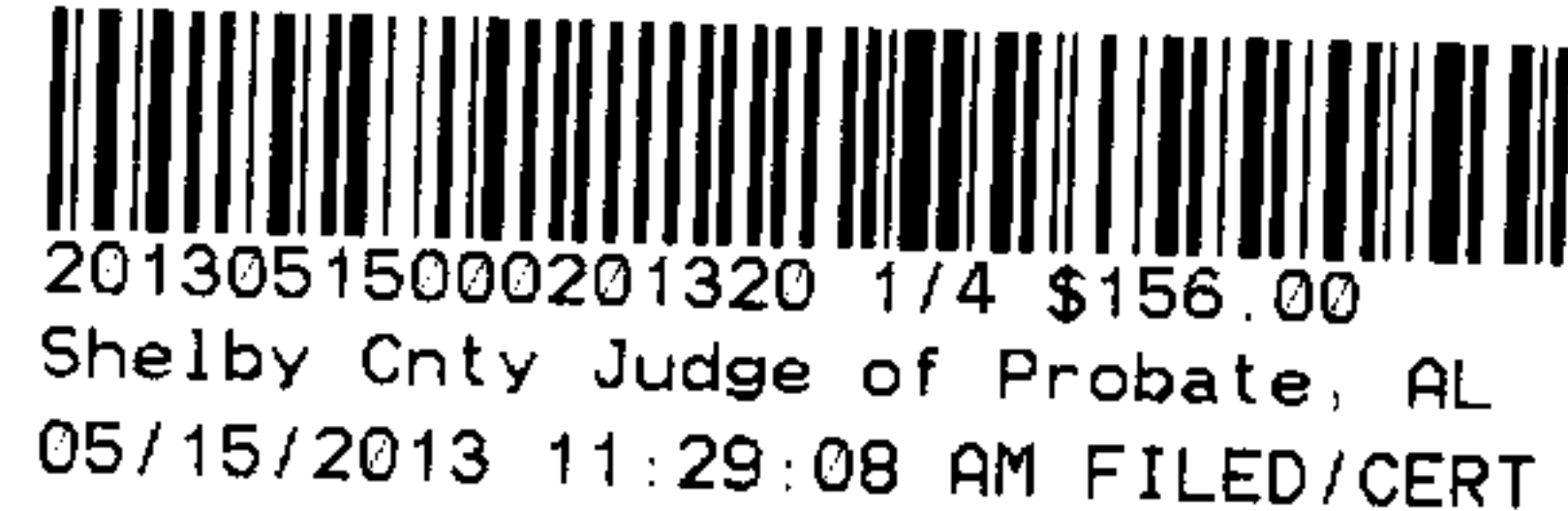

**ARTICLE ONE**

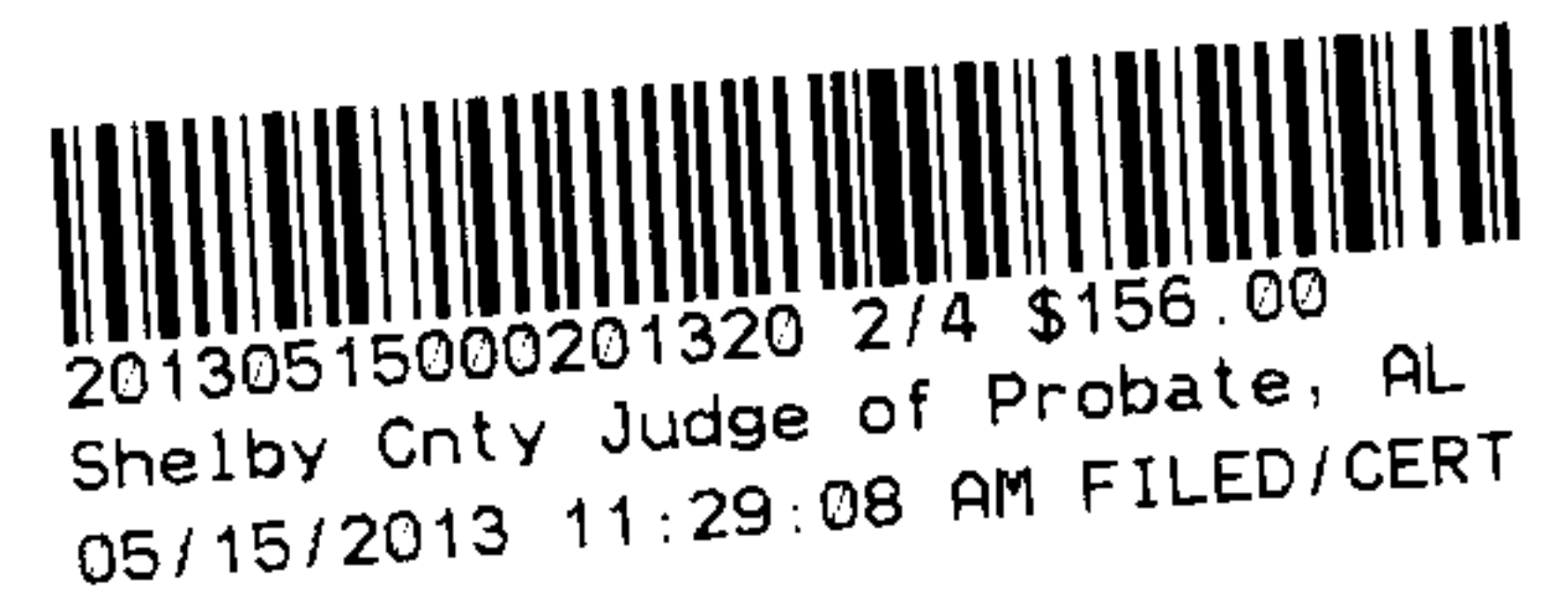
The name of the Limited Liability Company is: *JBH Partners, LLC*.

## ARTICLE SEVEN


