To execute any and all documents pertaining to the purchase of real property known as:

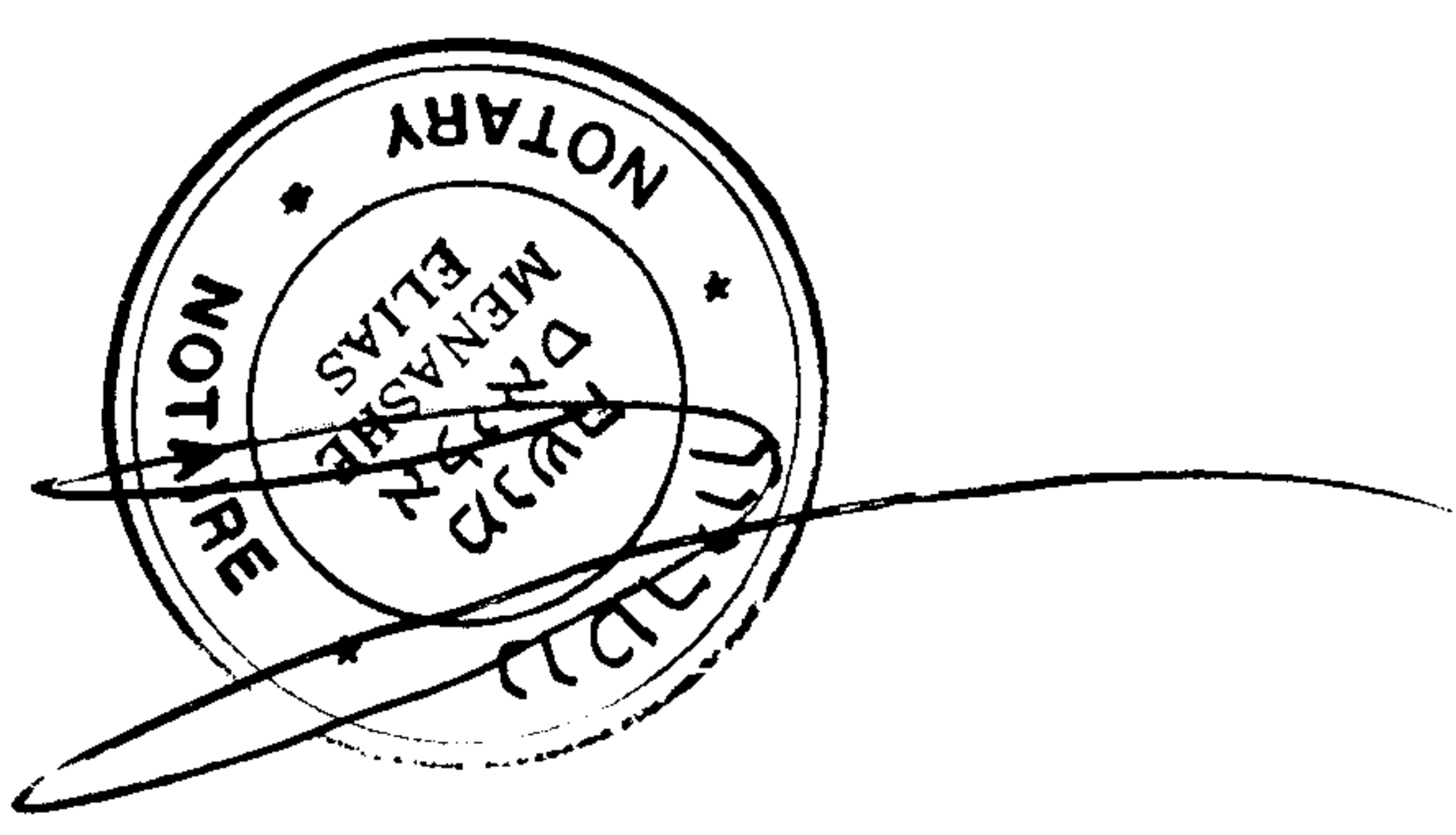
