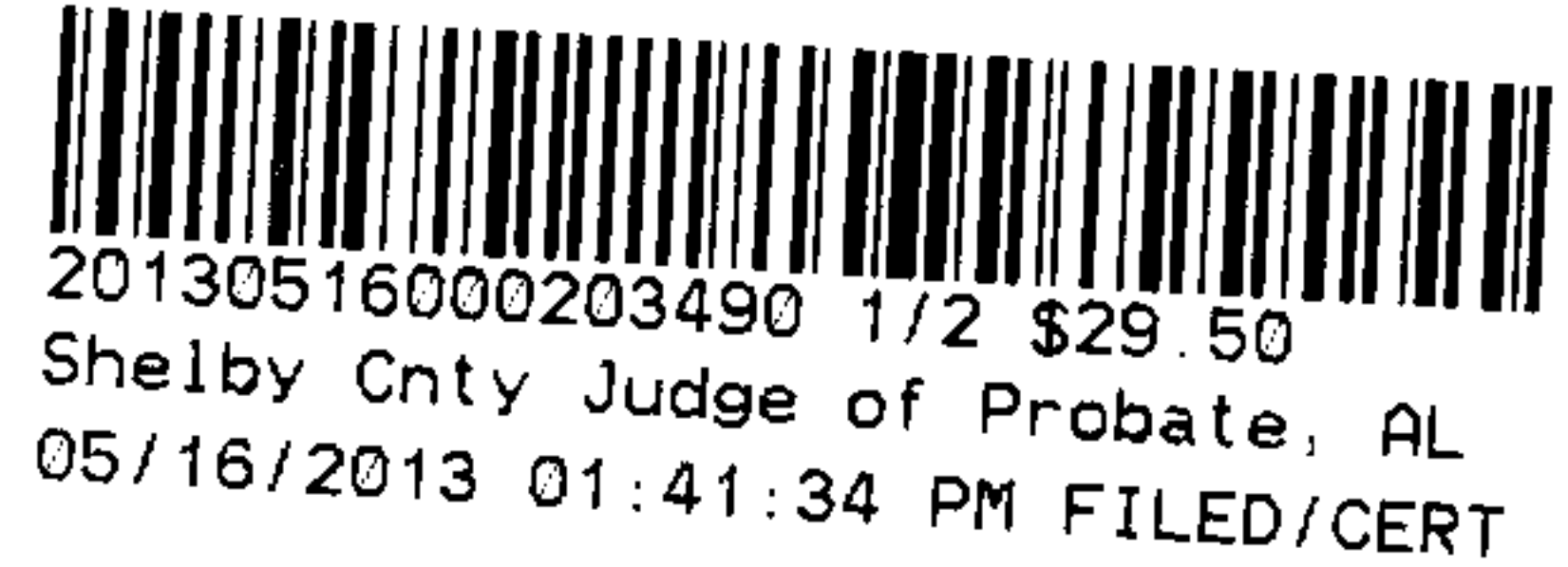

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Two Hundred Eighty-Six Thousand And No/100 Dollars (\$286,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, William R. Lumpkin and Ann C. Lumpkin, husband and wife (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Stephan A. Carew and Patsianne M. Hope-Carew (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 17, according to the Survey of Oak Forest, as recorded in Map Book 25, Page 111, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

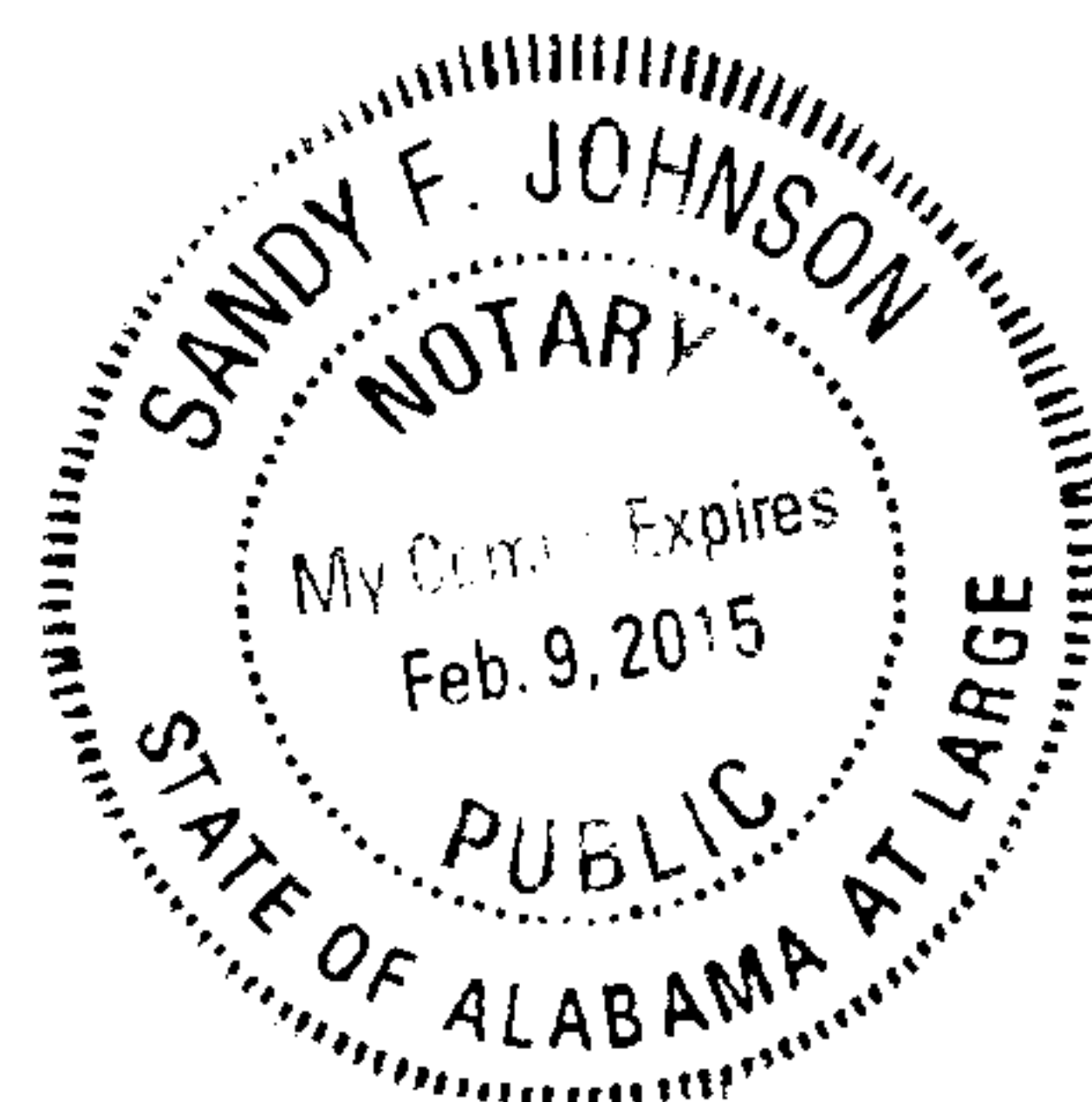

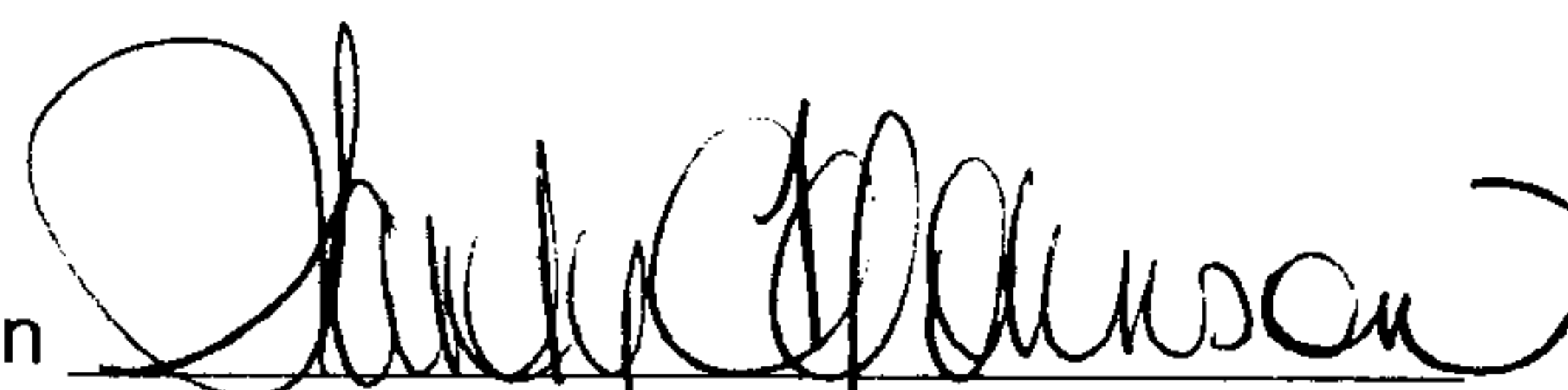
