PARTIAL RELEASE OF COALBED METHANE GAS LEASES

WHEREAS, Alabama Power Company and Southern Electric Generating Company, collectively as "Lessor", executed and delivered to CDX Gas, LLC and CDX Sequoya, LLC (collectively referred to herein as "CDX"), as "Lessee", that certain Corrected and Restated Coalbed Methane Gas Lease (hereinafter referred to as "Lease) dated July 9, 2004 and covering approximately 13,497.22 acres of land in Shelby County, Alabama, a Memorandum of which is recorded in the Office of the Judge of Probate of Shelby County, Alabama as Instrument No. 20050323000131220; and,

WHEREAS, Bowater Alabama Inc., as "Lessor", executed and delivered to CDX Sequoya, LLC (referred to herein as "CDX"), as "Lessee", that certain Coalbed Methane Gas Lease (hereinafter referred to as "Lease) dated October 12, 2004 and covering approximately 23,468.74 acres of land in Shelby and Bibb Counties, Alabama, a Memorandum of which is recorded in the Office of the Judge of Probate of Shelby County, Alabama as Instrument No. 20050303000100960; and,

WHEREAS, Kimberly-Clark Corporation, as "Lessor", executed and delivered to CDX Sequoya, LLC, CDX Gas, LLC, and CD Exploration, Inc. (collectively referred to herein as "CDX"), as "Lessee", that certain Coalbed Methane Gas Lease (hereinafter referred to as "Lease) dated November 29, 20044 and covering approximately 23,468.74 acres of land in Shelby and Bibb Counties, Alabama, a Memorandum of which is recorded in the Office of the Judge of Probate of Shelby County, Alabama as Instrument No. 20050303000100950; and,

WHEREAS, under the terms of a Partial Assignment, CDX assigned, with an effective date of November 1, 2006, all right, title and interest in 760 gross acres of each Lease cited above to GeoMet, Inc. ("GeoMet") resulting in GeoMet owning 760 net acres of leasehold. Said assignment is recorded in the Shelby County, Alabama Office of the Judge of Probate as Instrument No. 20061215000611770; and,

WHEREAS, under the terms of each Lease cited above, Lessee and its successors and assigns is given the right at any time or times to release and surrender all or any portion of each Lease and thereafter be relieved of all obligations under said Lease thereafter accruing as to the acreage surrendered; and,

WHEREAS, GeoMet desires to release and surrender unto Lessors only that certain acreage attributable to each said Lease cited above that is described on the attached Exhibit "A", said acreage comprising approximately 480 net acres of land in Shelby County, Alabama.

NOW, THEREFORE, for and in consideration of TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, GeoMet does hereby RELEASE, RELINQUISH and SURRENDER unto Alabama Power Company and Southern Electric Generating Company, Bowater Alabama Inc., and Kimberly-Clark Corporation, and their successors and assigns, all of GeoMet's right, title and interest in and under each Lease cited above, INSOFAR AND ONLY INSOFAR as said Lease covers those lands shown on the Exhibit "A" attached hereto comprising approximately 480 net acres of land in Shelby County, Alabama.

It is the intent of GeoMet to retain, and GeoMet does hereby retain, all right, title and interest in and to the remaining acreage set forth in said Leases, the retained acreage consisting of acres within production units established under the terms of the Leases and covering approximately 280 net acres. In addition, GeoMet specifically reserves and retains any and all rights-of-way, easements and privileges over, under, upon and across the released lands as are necessary or convenient for continuing operations and production of the wells located on the acreage retained.

It is expressly agreed and understood that this is a Partial Release of Coalbed Methane Gas Leases and that same shall in no way release or affect any other terms or conditions of said Leases, insofar as same covers the rights retained herein.


