KNOW ALL PERSONS BY THESE PRESENTS: That KIERSTEN DAHLHOFF, a single woman, did, on to-wit, May 16th, 2009, execute a mortgage to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for First Liberty Financial Group, LLC, which mortgage is recorded in Instrument No. 20090526000197110, et seq., in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage being lastly assigned to Bank of America, N.A. successor by merger to BAC Home Loans Servicing, LP fka Countrywide Home Loans Servicing, LP, now BANK OF AMERICA, N.A. by instrument recorded in Instrument No. 20120409000121950 in said Probate Court records; and


