ADVALOREM TAXES DUE OCTOBER 01, 2013 AND THEREAFTER.


BUILDING AND SETBACK LINES, RESTRICTIONS, COVENANTS AND CONDITIONS OF RECORD.

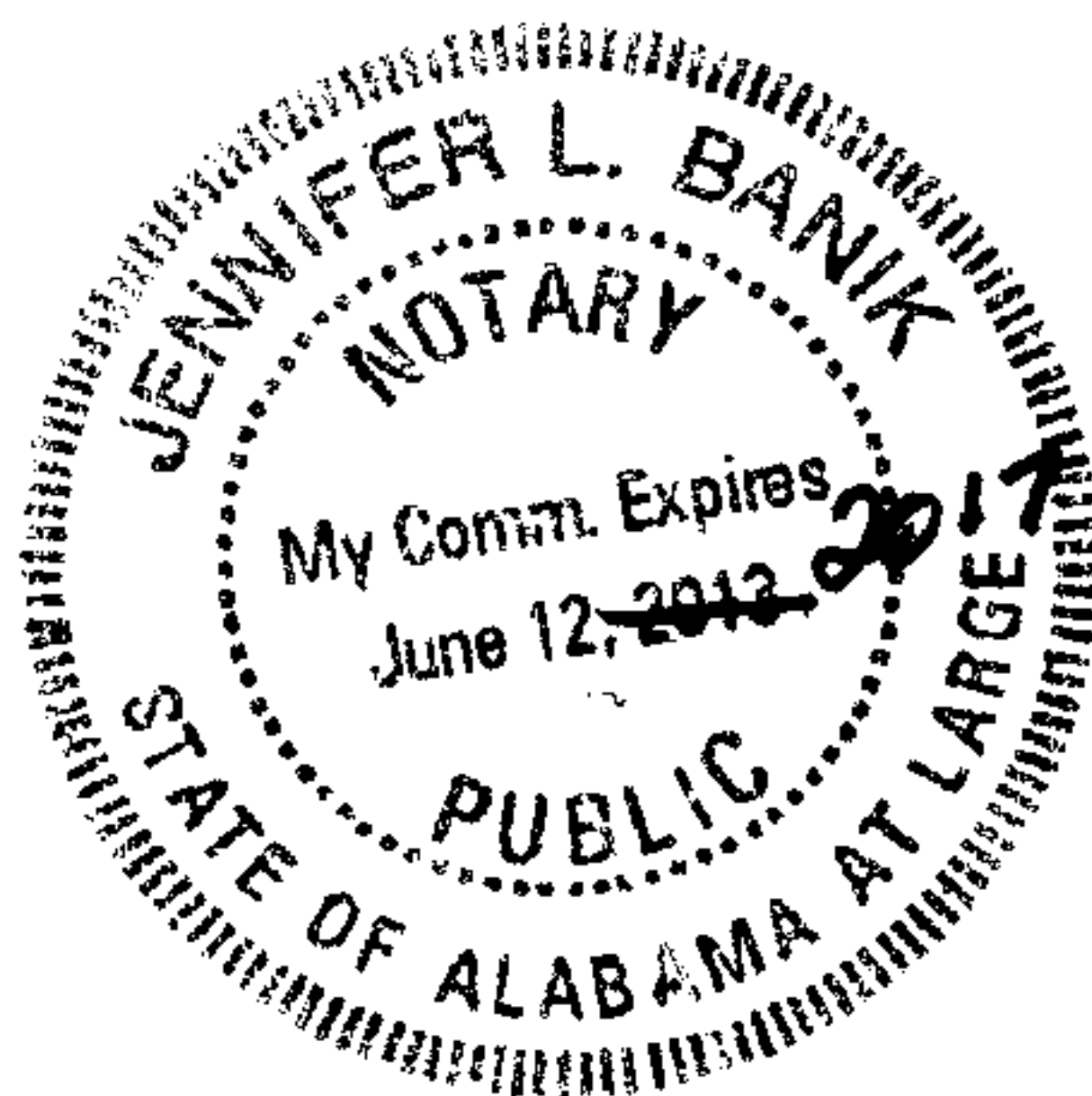


