} KNOW ALL MEN BY THESE PRESENTS,

SHELBY COUNTY

That in consideration of Three Thousand dollars and Zero cents (\$3,000.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Howard Baer, a single man (herein referred to as grantors) do grant, bargain, sell and convey unto Sam N. Meredith and Eleanor D. Meredith (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Begin at the NW corner of Lot 1 of The Willows of Calera, as recorded in Map Book 26, Page 85, in the Office of the Judge of Probate of Shelby County, Alabama, said point being the POINT OF BEGINNING; thence South 00 degrees 00 minutes 00 seconds East and along the West line of above said The Willows at Calera, a distance of 185.65 feet; thence North 86 degrees 46 minutes 33 seconds West, a distance of 149.93 feet; thence North 00 degrees 09 minutes 06 seconds West, a distance of 60.00 feet; thence South 86 degrees 46 minutes 33 seconds East, a distance of 70.00 feet; thence North 00 degrees 08 minutes 55 seconds West, a distance of 125.55 feet; thence South 86 degrees 52 minutes 05 seconds East, a distance of 80.40 feet to the POINT OF BEGINNING. 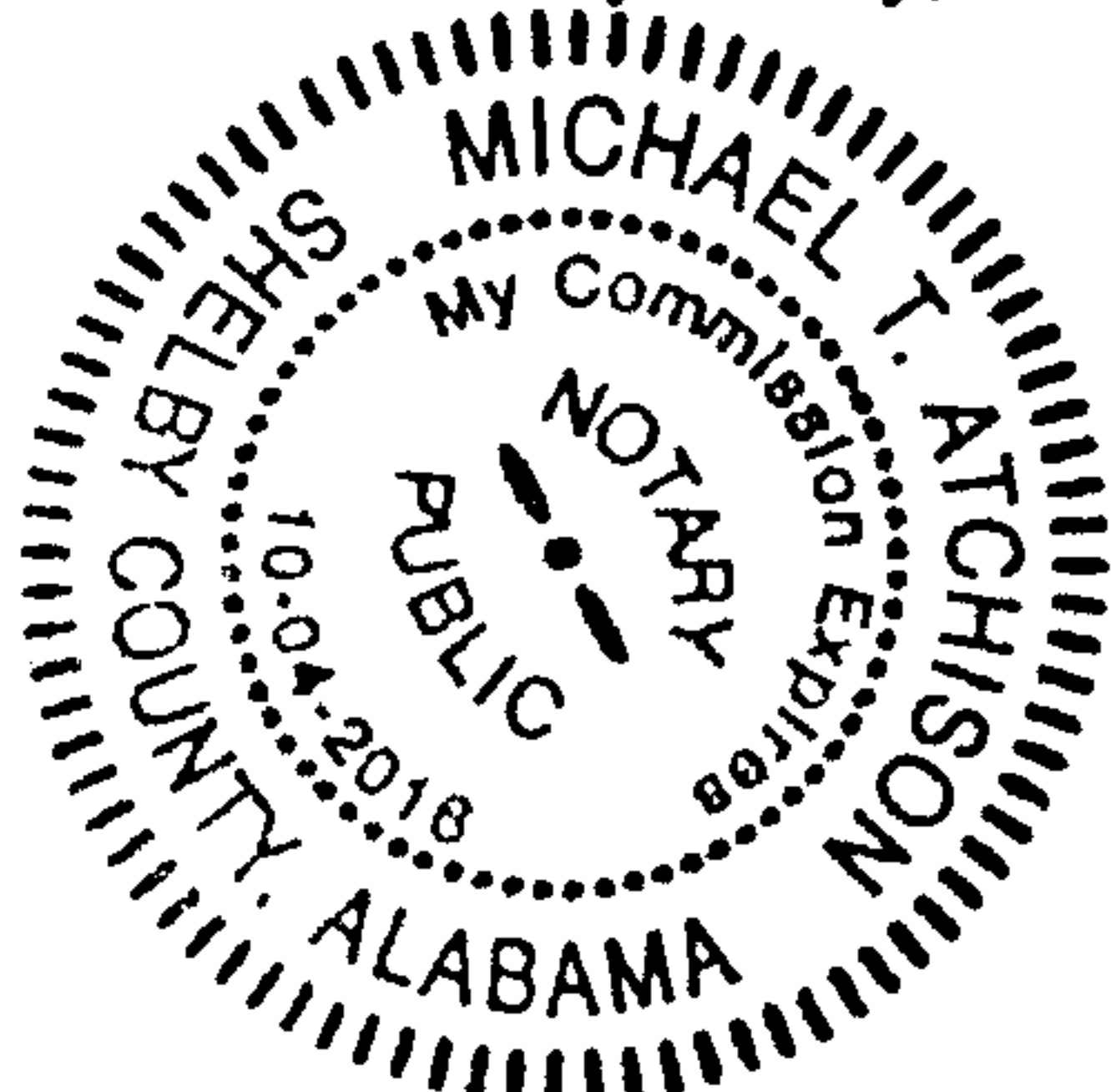
