Know All Men by These Presents: That in consideration of **Two hundred eighty three thousand nine hundred and no/100 (\$283,900.00)**, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Donovan Builders, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Paige Lightsey and Mark Daniel Hudson** (herein referred to as grantee, as joint tenants of survivorship, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:




