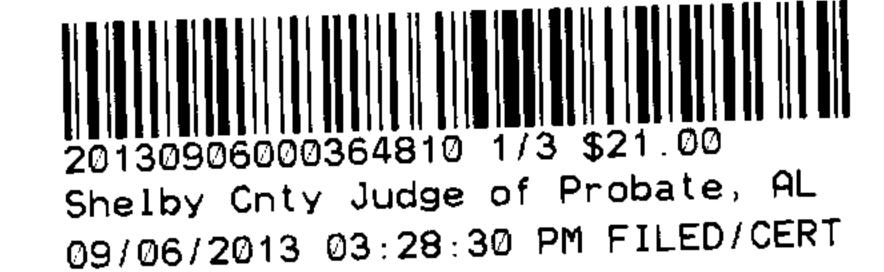
FORECLOSURE DEED

KNOW ALL PERSONS BY THESE PRESENTS: That Abigail L Sinclair and Timothy D Sinclair, Husband and Wife, did, on to-wit, August 27th, 2009, execute a mortgage to Mortgage Electronic Systems, Inc., acting soley as nominee for Hometown Mortgage Services, Inc., An Alabama Corporation which mortgage is recorded in Instrument #20090903000341710, et seq., in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage being lastly assigned to Nationstar Mortage, LLC in Instrument #20130703000272490, et seq., in the Office of the Judge of Probate of Shelby County, Alabama; and
