**ARTICLES OF ORGANIZATION  
OF  
RCSC HOLDING COMPANY, LLC**

We, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1.     **NAME OF LIMITED LIABILITY COMPANY:** The name of the Limited Liability Company is **RCSC HOLDING COMPANY, LLC**.

2.     **PERIOD OF DURATION:** The existence of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue indefinitely, provided, however, that the Limited Liability Company shall be dissolved prior to such date (a) upon the written consent of all of the Members; (b) as provided in the Operating Agreement of the Limited Liability Company; or (c) as may be required or provided for by the Alabama Limited Liability Company Act.

3.     **PURPOSE:** The purpose for which this Limited Liability Company is organized is:

(a)     To hold monies from investments and for reinvestment; engage in currency speculation; hold properties and engage in property development, maintenance and rental and all other related activities.

(b)     To render to others, and to engage in the business of rendering to others, consulting, advisory, administrative and other services of every nature, kind and character, which it may legally render;

(c)     To act as agent, representative, or receiver of any person, firm, corporation or

governmental entity or instrumentality in respect to any lawful undertaking or transaction;

(d) To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;

(e) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, associations, partnerships, limited liability companies, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;

(f) To lend money, invest and reinvest its funds and take and hold real and personal property as security for the payment of funds so loaned or invested; and

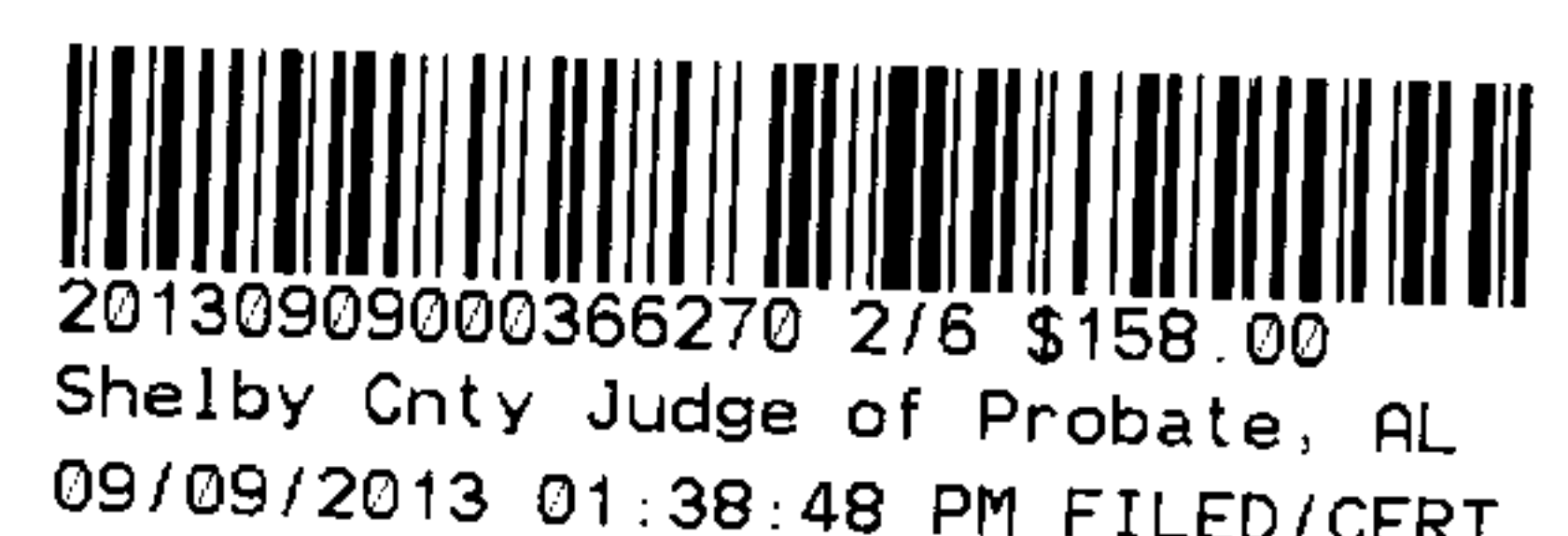
(h) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.

4. **INITIAL REGISTERED OFFICE AND AGENT:** The Company's original principal place of business in Alabama is at the address of its initial registered agent, and the name and address of the initial registered agent at that address is as follows:

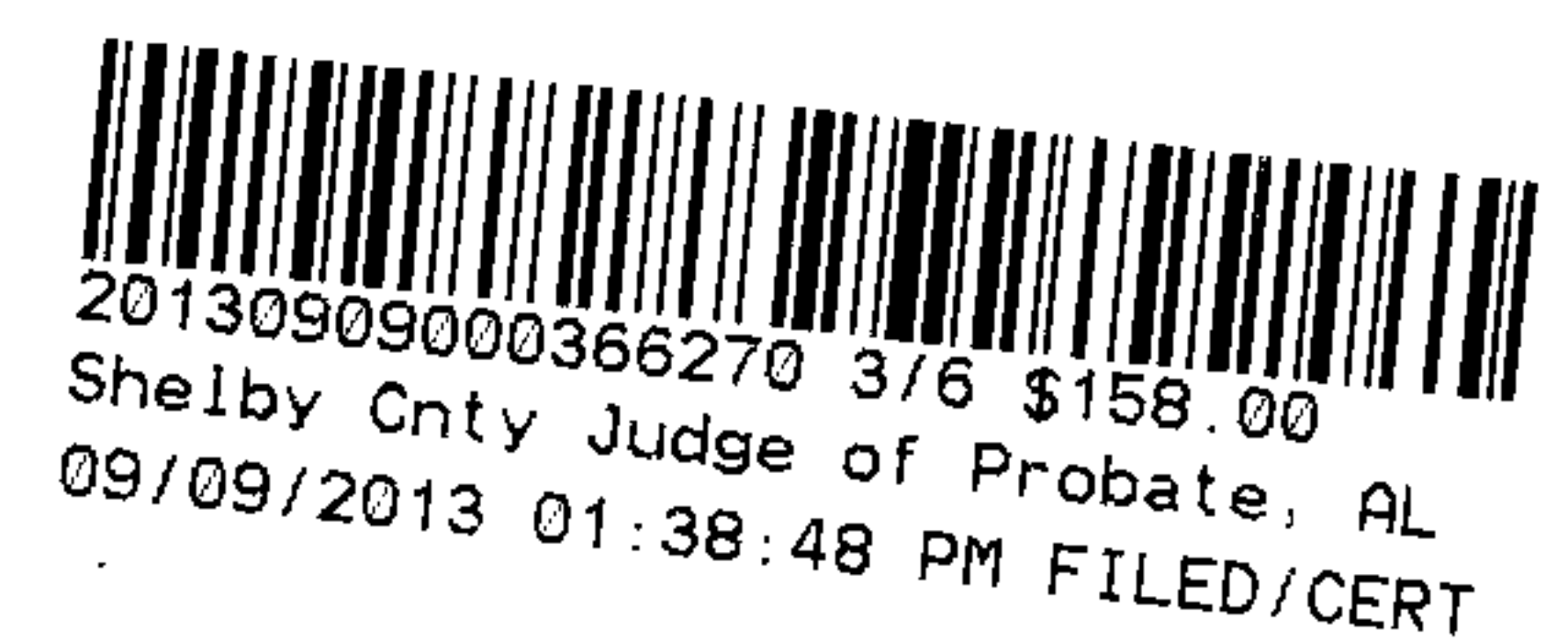
6. **MANAGER:** The Limited Liability Company shall have a Manager. The name of the Manager is Raymond R. Carter, whose mailing address is 194 Brandy Lane, Harpersville, Alabama 35078.

7. **RIGHT, TERMS AND CONDITIONS OF ADMITTING NEW MEMBERS:**  
The Members of the Limited Liability Company reserve the right to admit additional Members to the Limited Liability Company upon compliance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

8. **MEMBERS RIGHT TO CONTINUE BUSINESS AFTER EVENT OF DISSOCIATION:** The Members of the Limited Liability Company shall have the right to continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or upon the occurrence of any event which terminates the continued membership of a Member in the Limited Liability Company, the remaining Members may agree to continue the operation of the Limited Liability Company by unanimous written consent within ninety days after the Withdrawal of a Member. This may be further regulated by the Operating Agreement of the Limited Liability Company, which must not be inconsistent herewith.

9. **LIABILITIES OF MEMBERS:** No Members of the Limited Liability Company can be held liable under a judgment, decree or order of any court, or in any other manner, for a debt, obligation or liability of the Limited Liability Company, or for the acts or omissions of any other Member, Agent or Employee of the Limited Liability Company.



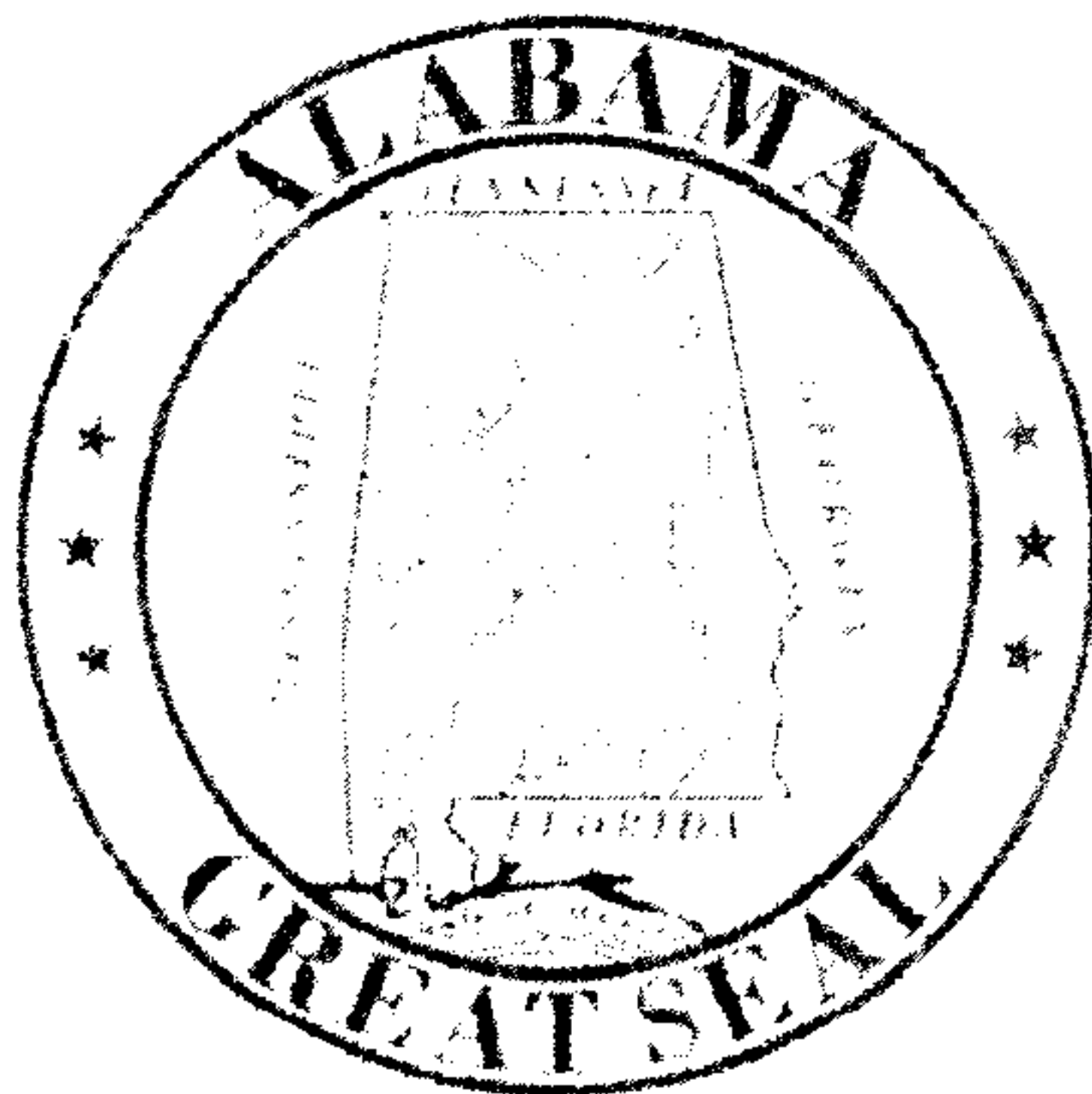
