KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, heretofore, on, to-wit: the 1st day of October, 2008, Sharon L. 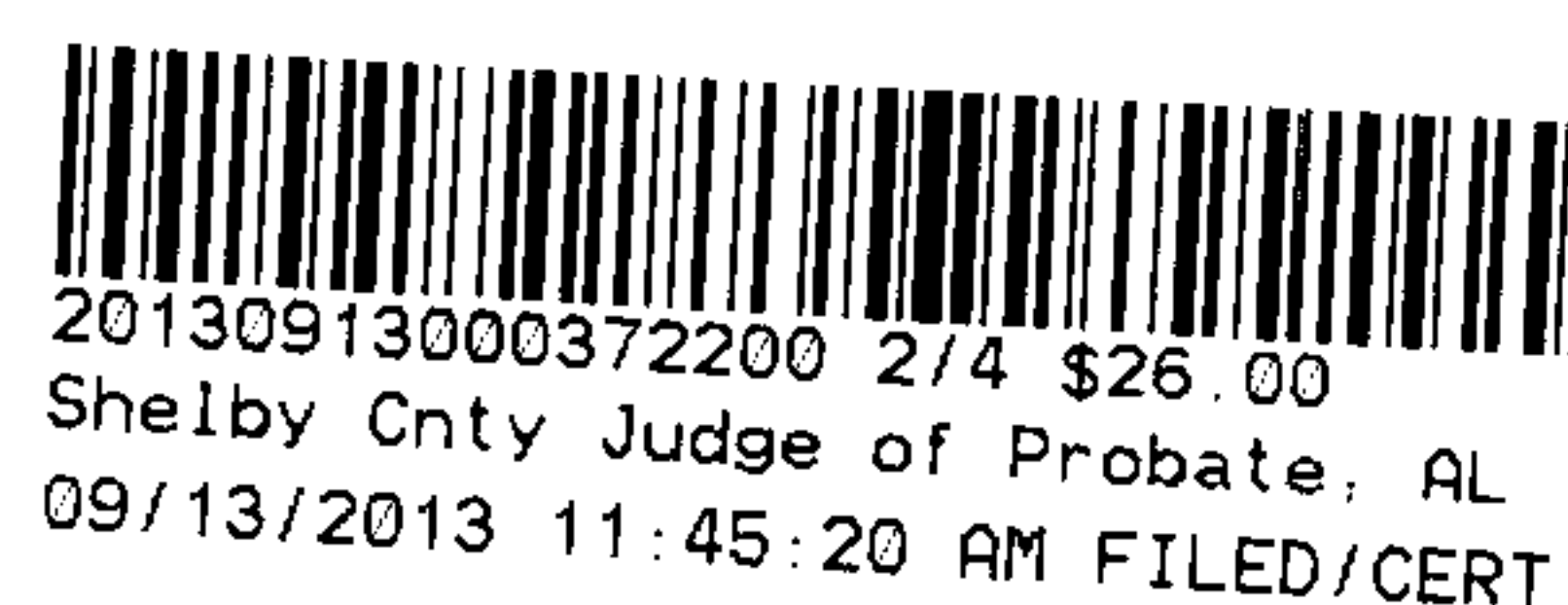

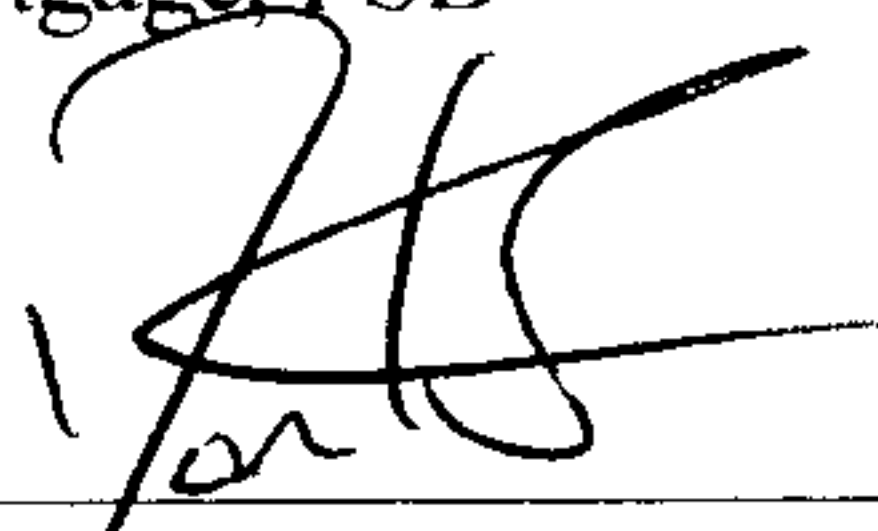
