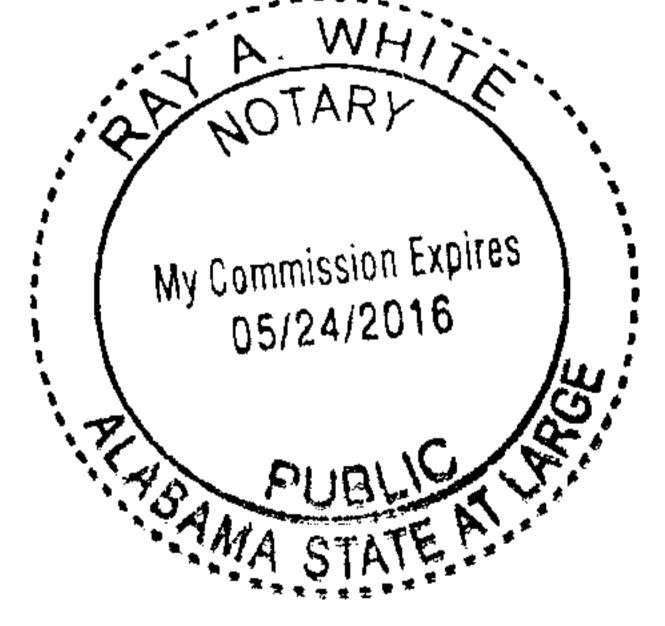

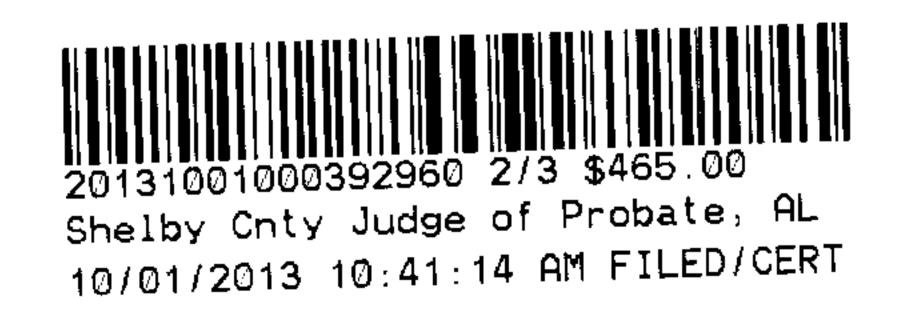
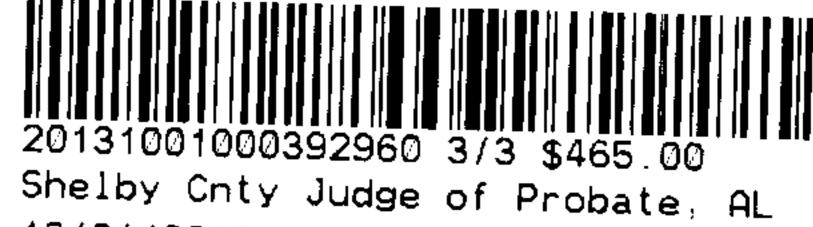


EXHIBIT "S"
