Know all Men by these Presents: That, in consideration of Two Hundred Fifty Thousand and No/100ths Dollars (\$250,000.00) and other good and valuable consideration to her in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **JACQUELINE H. CONVILLE and Husband, DONALD HOWARD** (herein referred to as "Grantor") does by these presents grant, bargain, sell and convey unto **ROBERT W. PICOU, SR. AND BRENDA G. 




