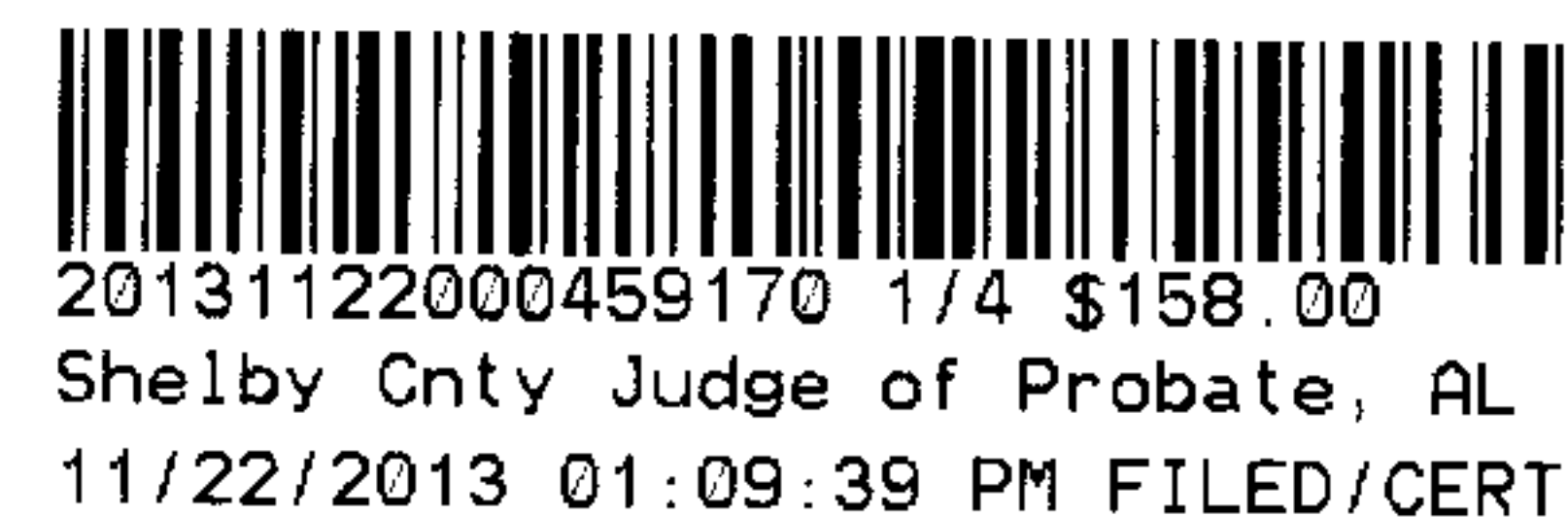


**ARTICLES OF ORGANIZATION**  
**OF**  
**LETITGO, L.L.C.**



The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the Code of Alabama, (1975), as amended (the "Alabama Limited Liability Company Act"), hereby file the following Articles of Organization with the probate judge of the county in which the initial registered office of the limited liability company will be located and affirm that the facts stated in these Articles of Organization are true and correct:

**ARTICLE I**  
**Name**

The name of the limited liability company ("Company") is LETITGO, L.L.C.

**ARTICLE II**  
**Duration**

The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act.

**ARTICLE III**  
**Purposes**

The Company has been organized for the primary purposes of providing marketing and administrative services for counselors and for any lawful purpose or purposes for which a limited liability company may be organized under the laws of the State of Alabama.

**ARTICLE IV**  
**Registered Agent and Office**

### **Continuity of Business**




**ARTICLE IX**  
**No Liability**


The members of the Company shall have no liability for any debt, obligation, or liability of the Company, as provided in the Alabama Limited Liability Company Act.






