That in consideration of **Three Hundred Twenty-Five Thousand and 00/100 Dollars (\$325,000)** to the undersigned grantor in hand paid by the grantee herein, the receipt and sufficiency of which is acknowledged, I,

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

Judith A. Lunsford and Gary H. Lunsford as Trustees of the Judith A. Lunsford and Gary Hamilton Lunsford Living Trust, dated the 16th of May 2013

(hereinafter referred to as "Grantee") the following described real estate situated in **Shelby County, Alabama** to-wit:
