GENERAL WARRANTY DEED
Joint Tenant with Rights of Survivorship

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of **Two Hundred Thirty-Five Thousand and NO/100 Dollars (\$235,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Jeremy W. Young and Elise Young, husband and wife

(herein referred to as Grantors), grant, bargain, sell and convey unto

Paige E. Fitzgerald and Cathy H. Fitzgerald

(herein referred to as **Grantees**), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama to wit:

Lot 1 of Hearthwood Subdivision as recorded in Map Book 16, page 27, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.


Subject to easements, rights of way, set back lines, restrictions, covenants, mineral and mining rights not owned by the grantors and current taxes due.


\$160,000.00 of the above consideration was secured by and through the purchase money mortgages closed and recorded herewith.




