Assignee hereby agrees that Assignee will assume all of the obligations, rights and responsibilities of the Assignor with respect to the ownership of said Membership Interest. The Assignee further agrees to consent and be bound by the terms of the Operating Agreement of the Company with respect to said Membership Interest.

In further consideration of the premises and the mutual covenants of the parties, Assignor does hereby indemnify and hold harmless Assignee from any and all claims, demands, damages, actions or causes of actions, obligations, responsibilities, liabilities, loss, claims, costs or expenses, including attorneys fees associated with Assignor's ownership of the Membership Interest, and Assignee does hereby indemnify and hold Assignor harmless from any and all claims, demands, damages, actions or causes of action, obligations, responsibilities, liabilities, loss, claims, costs or expenses, including attorneys fees associated with Assignee's ownership of the Membership Interest.

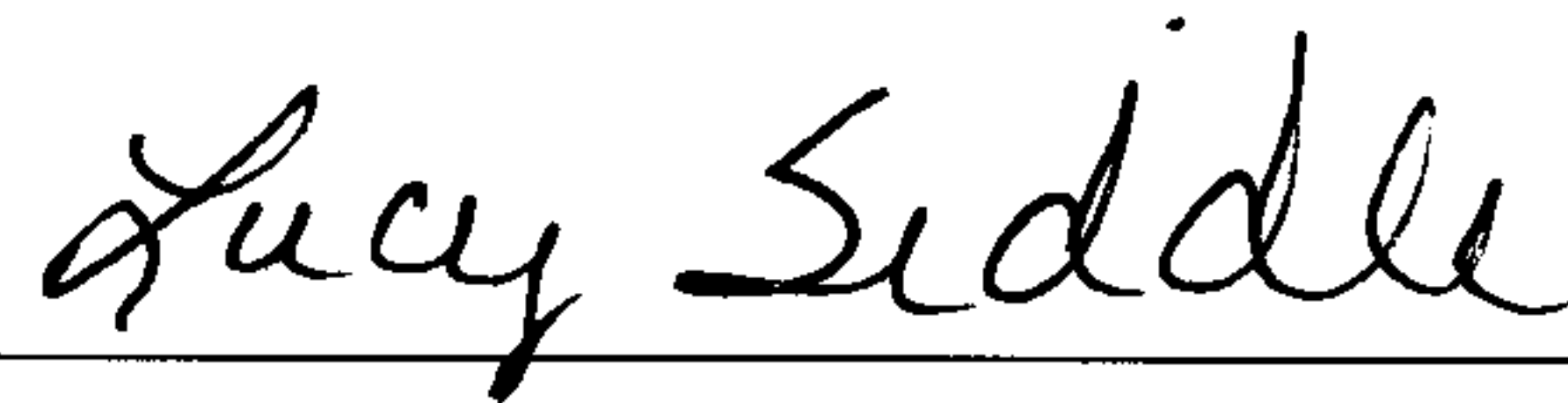
3. This Assignment shall be binding upon and shall inure to the benefit of the successors and assigns of each of the parties hereto.

5. Any amendment to this Agreement must be in writing and signed by all parties hereto.

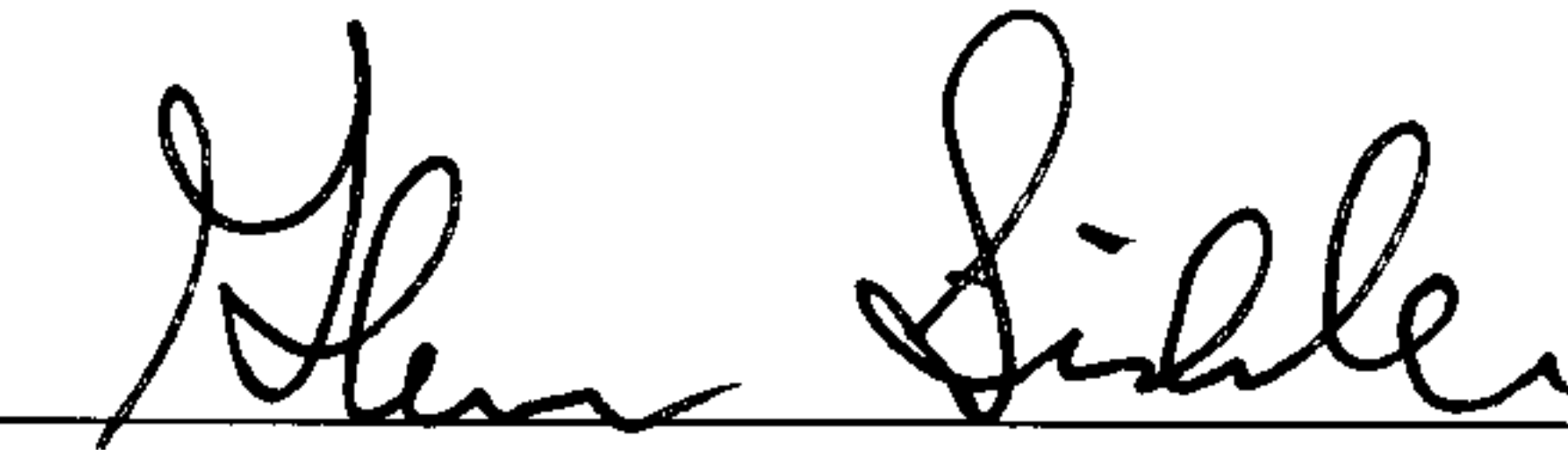
