JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA.

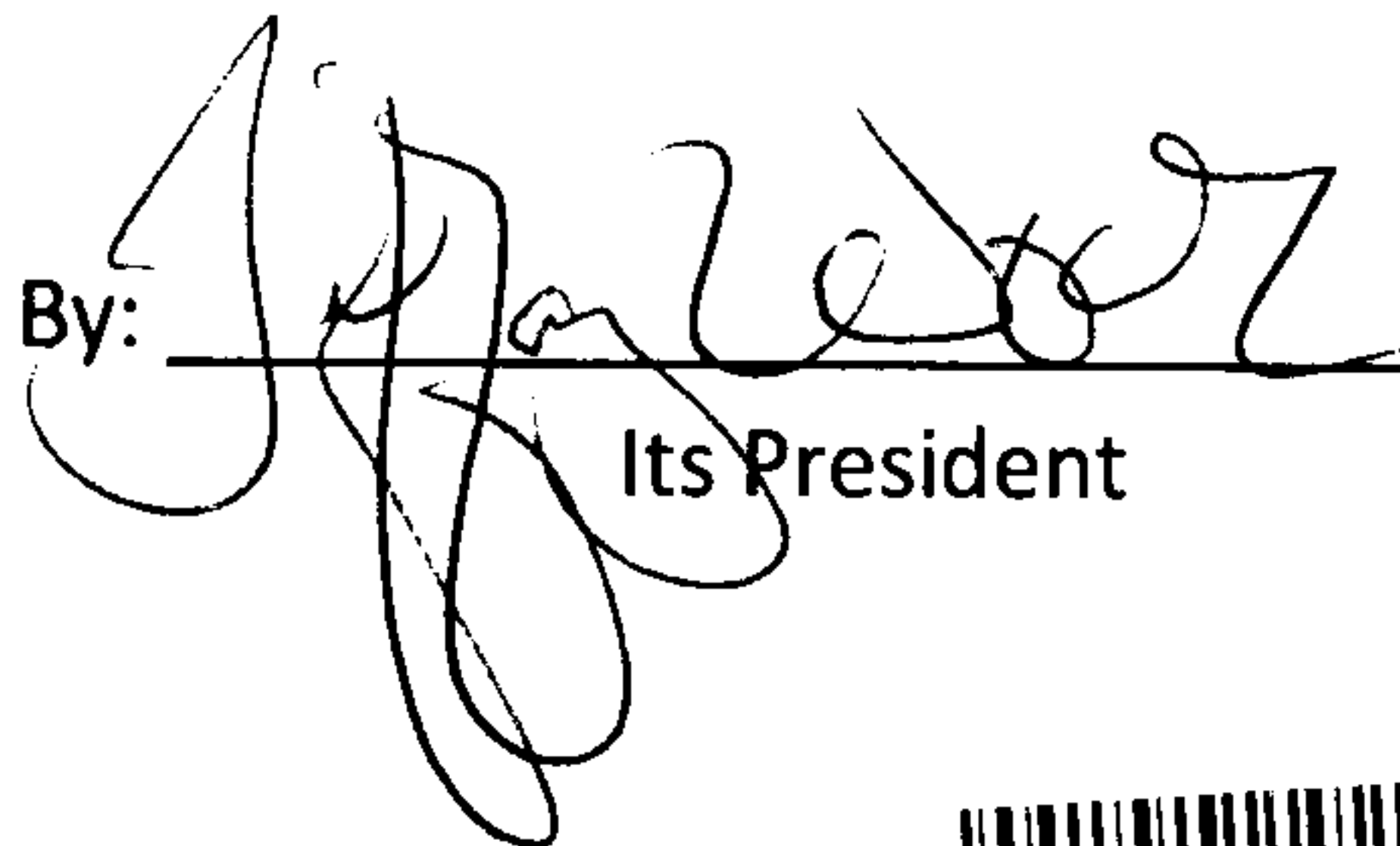
